我很高興向大家發表二零一五至一六年度公司註冊處年報。在這一年，本處再次取得美滿成績；我們鞏固了實力，並繼續竭盡所能為香港建設一個有利營商的環境。本報告概述本處的服務表現，以及我們為香港帶來的改進。

繼續服務商界

本處負責實施及執行《公司條例》及相關法例的規定。新《公司條例》自二零一四年三月實施後，一直運作暢順，令我引以為傲。這進一步加強了香港作為國際金融和商業中心的地位。

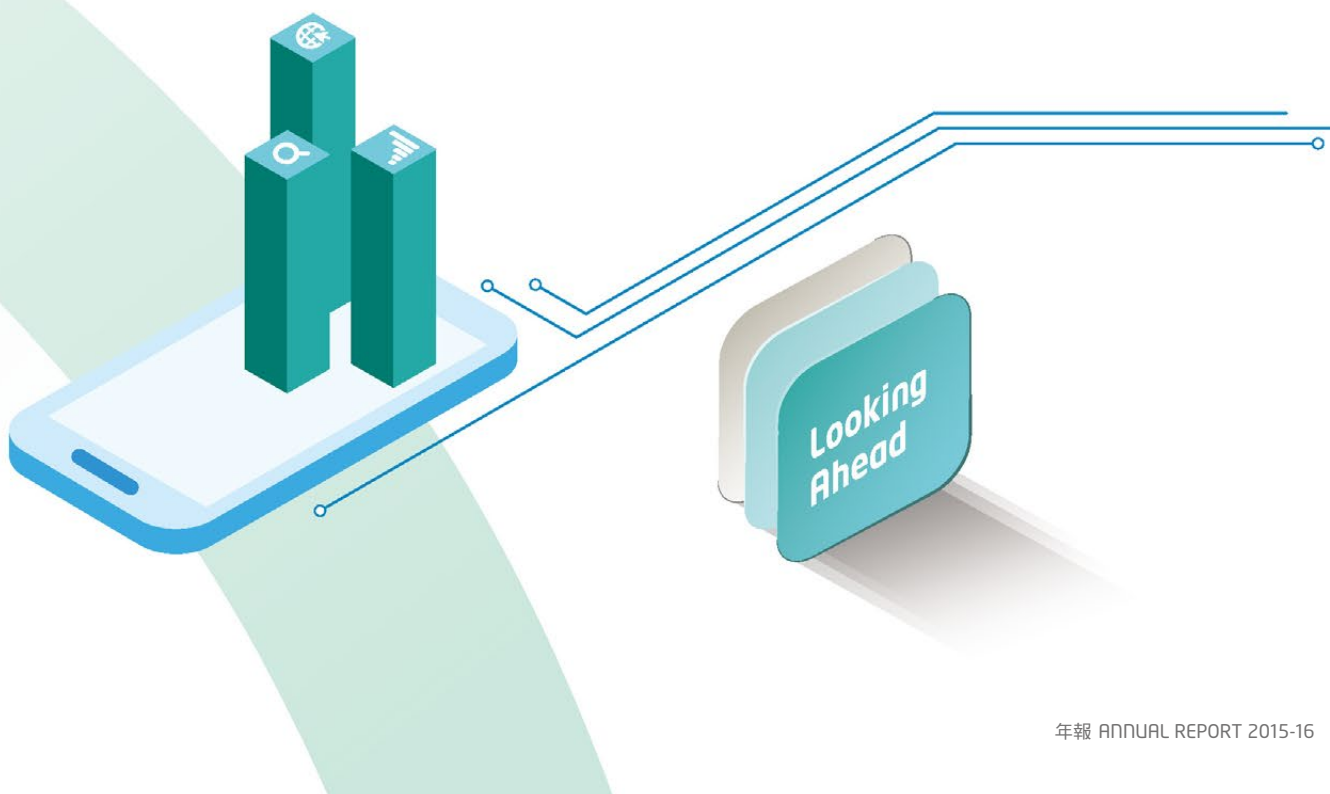
本處的主要職能，包括為公司辦理註冊；為法定申報表辦理登記事宜；為公眾提供服務，讓他們取得法定登記冊所載的公司資料。我們竭力為公司、公司股東及董事提供優質服務，方便他們營商，並繼續實施新《公司條例》以促進香港作為理想營商之都的競爭力。

I am pleased to present the Companies Registry's Annual Report for the year 2015-16. It has been another successful year for the Registry during which we consolidated our strength and continued to contribute to building a business-friendly environment in Hong Kong. This report outlines how we are performing, and the positive changes we are making for Hong Kong.

Continue to Serve the Business Community

The Registry is responsible for administering and enforcing the provisions of the Companies Ordinance and related legislation. I take pride in the fact that operation under the new Companies Ordinance, which was first implemented in March 2014, continues to be smooth. This further reinforces Hong Kong's position as an international financial and commercial centre.

The Registry's primary functions include the registration of companies and statutory returns and the provision of services for members of the public to obtain company information held on statutory registers. We endeavour to provide quality services to companies, their shareholders and directors to facilitate their businesses, and continue to implement the new Companies Ordinance to foster Hong Kong's competitiveness as an ideal place to do business.



在二零一五至一六年度，我們繼續在各方面提升客戶服務。具體而言，本處：

- 處理了 135,358 間新公司註冊成立的申請。截至二零一六年三月三十一日為止，共有 1,293,295 間本地公司在公司登記冊上，數目創新高；
- 收到交付本處登記的文件有 2,593,120 份，與去年的水平相若；
- 處理了 3,895,298 宗文件影像紀錄的查冊，較去年增加 3.8%；及
- 提供了在流動裝置進行的公司查冊有 3,331,039 宗，即平均每日超過 9,000 宗。

建立首屈一指的公司註冊處

根據世界銀行發表的《2016 年營商環境報告》，在 189 個經濟體中，香港繼續在「保障小股東投資者」方面獨佔鰲頭，世界銀行讚揚香港在新《公司條例》下新增要求董事更詳細披露利益衝突的規定。此外，香港在「開辦企業」方面的國際排名亦躍升四級至第四位。

為了充分掌握國際發展及最佳做法，本處積極聯繫世界各地的公司註冊機構，以司庫及論壇理事身份參與一個為公司／商業註冊機構而設的國際性組織「公司註冊論壇」。

我十分高興知道，我們在優化服務方面的共同努力得到認同。年內，本處榮獲：

- 「2015 年公務員優質服務獎勵計劃」的「部門精進服務獎」（小部門組別）金獎；

In 2015-16, the Registry continued to enhance our customer service on all fronts. In particular, we:

- Handled the incorporation of 135,358 new companies with the number of local companies on the register reaching a record of 1,293,295 as at 31 March 2016;
- Received 2,593,120 documents for registration, at same level as last year;
- Processed 3,895,298 searches of document image records, an increase of 3.8 per cent over last year; and
- Provided 3,331,039 company searches through mobile devices, on average more than 9,000 mobile searches daily.

Build a First Class Registry

According to World Bank's "Doing Business 2016" report, Hong Kong has sustained its top position as the first in "protecting minority investors" among 189 economies. The World Bank commended Hong Kong for introducing requirements for directors to provide more detailed disclosure of conflicts of interest under the new Companies Ordinance. Hong Kong's ranking in "starting a business" also went up four places to fourth internationally.

To keep abreast of international developments and best practices, we have been playing an active role in liaising with registries across the world through participation as the Treasurer and Conference Director of the Corporate Registers Forum, an international organisation of corporate/business registrars.

It gives me great pleasure to note that our concerted efforts in service enhancements have not gone unnoticed. In the year, we received:

- the Gold Prize of the Departmental Service Enhancement Award (Small Department Category) under the Civil Service Outstanding Service Award Scheme 2015;

- 本處二零一四至一五年度報榮獲二零一五至一六年度「Mercury 國際年報大獎」兩個銅獎（「封面設計：抽象 / 圖像」組別及「內頁設計—傳統格式」組別）；及
- 超越 5 年「同心展關懷」標誌，以表揚本處互助互勉的機構文化及社區外展服務。
- the status of “Manpower Developer” under the Employees Retraining Board Manpower Developer Award Scheme for our outstanding achievement in manpower training and development;
- the Best SME's Partner Award for the seventh year for our services and support to the small and medium enterprises;
- the Bronze Award in the “Non-Profit Organisation: Government Agencies & Offices” category of the 2015 International Annual Report Competition Awards for our 2013-14 Annual Report;
- two Bronze Awards in the 2015-16 MERCURY Excellence Awards under the “Cover Design: Abstract/Graphics” and “Interior Design: Traditional Format” categories for our 2014-15 Annual Report; and
- the “5 Years Plus Caring Organisation” logo in recognition of our supportive organisation culture and community outreach.

策劃未來 創新服務

本處一向致力以創意和先進科技拓展我們的電子服務，以服務客戶，因此多年來本處不斷為「公司註冊處綜合資訊系統」進行提升工程。我們的主要電子服務包括：

- 全日 24 小時運作的網上查冊中心，提供查閱公司資料的電子查冊服務；
- 「公司查冊流動版服務」（下稱「流動版服務」），讓客戶可隨時隨地使用智能手機及流動裝置進行公司查冊。涵蓋全面的查冊服務及功能的流動版服務已於二零一六年五月推出；
- Electronic searches of company information through Cyber Search Centre (“CSC”) which operates round-the-clock;
- Company Search Mobile Service (“CSMS”) which enables customers to conduct company searches anytime and anywhere using smart phones and mobile devices. A full scale CSMS covering all search services and functions was launched in May 2016;

Innovate for Tomorrow

The Registry has been at the forefront in applying innovative ideas and technology to expand the electronic services provided to our customers through ongoing enhancements of the Integrated Companies Registry Information System (“ICRIS”). Our major electronic services include:

- 「註冊易」提供一站式電子成立公司暨商業登記服務，以及涵蓋所有指明表格的全面電子提交文件服務；及
 - 其他協助公司遵從法規的增值服務，例如「周年申報表e提示」服務及「監察易」服務等。
- One-stop electronic service for company incorporation and business registration and a full scale electronic filing service covering all specified forms at the e-Registry; and
 - Other value-added services to facilitate companies' compliance, such as Annual Return e-Reminder service and e-Monitor service.

為善用最新的資訊科技，我們已於二零一六年年初完成一項「部門資訊科技規劃」研究，該項研究包括全面檢討本處的資訊科技策略、未來發展及相關基礎設施。

With a view to keeping pace with technological advancements, we completed a Departmental Information Technology Planning ("DITP") study in early 2016 which encompasses a comprehensive review of the Registry's IT strategy, future development and the related infrastructure.

展望未來，我們計劃在二零一七年為較常提交的表格推出流動版電子表格提交服務，並會提升「公司註冊處綜合資訊系統」以配合引入開放式基金型公司這新一類公司。我們亦會落實「部門資訊科技規劃」研究報告的建議，包括設立新一代資訊科技基礎設施及徹底翻新「公司註冊處綜合資訊系統」。

In the years ahead, we plan to launch a Mobile e-Form Filing service for commonly filed forms in 2017 and enhance the ICRIS to cater for the introduction of a new type of companies, namely Open-ended Fund Companies. We will also implement the proposals recommended in the DITP study, including the establishment of a new generation IT infrastructure and a complete revamp of ICRIS.

總結

Concluding Remarks

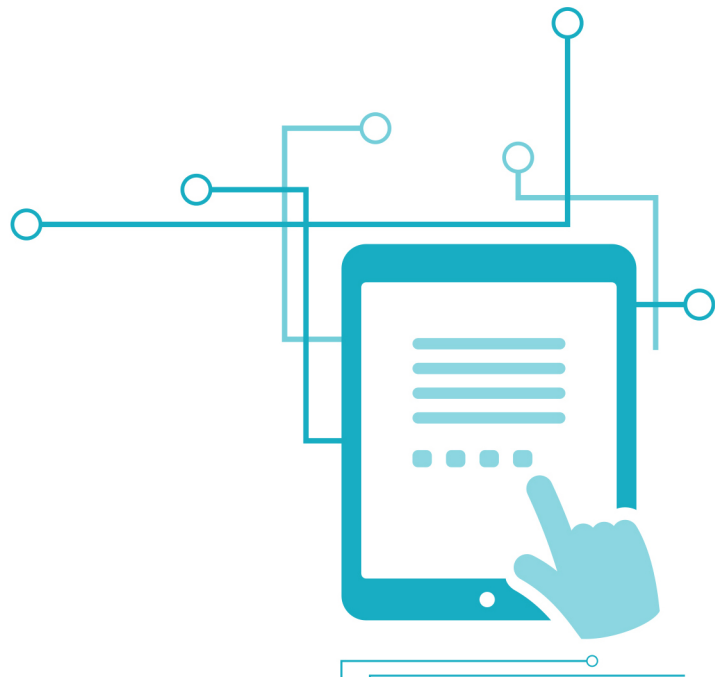

業務回顧與分析 Business Review and Analysis

業務運作

公司註冊成立及解散

根據世界銀行就全球 189 個經濟體的表現所發表的《2016 年營商環境報告》，香港在「開辦企業」方面的國際排名跳升四級至全球第四位。

在二零一五至一六年度，新公司註冊成立的數目共有 135,358 間，按年輕微下跌 5.6%，當中由一名成員組成的公司約佔 81%。每月平均有 11,280 間新公司列入公司登記冊（下稱「登記冊」），即平均每個工作日約有 552 間新公司。

另一方面，在同一個財政年度，共有 123,787 間公司解散，較前一年激增 82.8%，這主要因為本處採取特別行動，把不營運的公司從登記冊中剔除。在該些已解散的公司當中，有 49,098 間公司被撤銷註冊，有 73,648 間公司的名稱從登記冊剔除，以及有 1,041 間公司以清盤的方式解散。

Business Operations

Incorporation and Dissolution of Companies

As stated in World Bank's report on "Doing Business 2016", which compares the performance of 189 economies worldwide, Hong Kong's ranking in "starting a business" went up four places to fourth internationally.

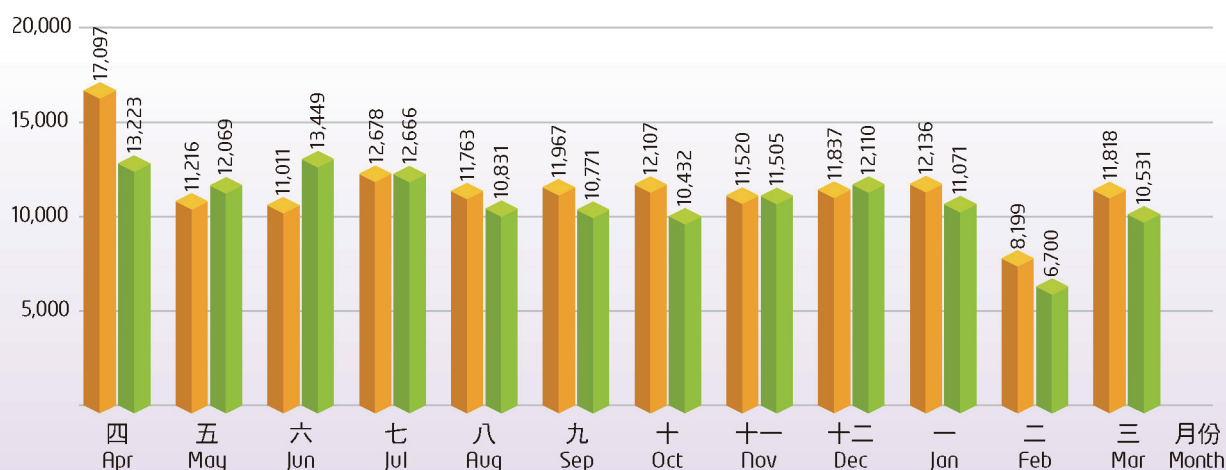
In 2015-16, the number of new companies incorporated showed a moderate year-on-year decrease of 5.6 per cent to 135,358, of which about 81 per cent were one-member companies. On average, 11,280 new companies were added to the Companies Register ("the Register") every month, which represented an average of around 552 new companies per working day.

On the other hand, 123,787 companies were dissolved in the same year, representing a surge of 82.8 per cent from the previous year, mainly due to a special exercise conducted to strike off defunct companies on the Register. Out of the dissolved companies, 49,098 companies were deregistered; 73,648 companies were struck off the Register and 1,041 companies were dissolved by liquidation.

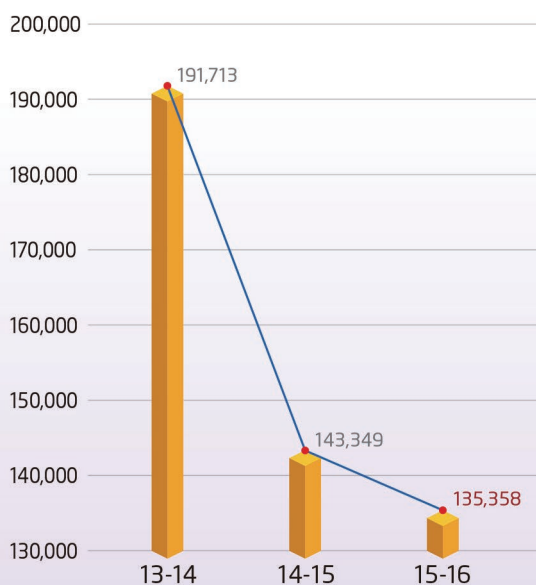

文件登記

在二零一五至一六年度，交付本處登記的文件數目共有 2,593,120 份，平均每個工作日 10,500 份，與前兩年比較，本年度的數目保持平穩。

交付本處登記的文件與公司在不同範疇的運作有關，包括公司組織章程細則、董事及公司秘書的委任、辭職及其有關詳情更改的通知書、註冊辦事處地址更改通知書、股份配發申報書和周年申報表等。

Registration of Documents

In 2015-16, the number of documents received for registration remained steady at 2,593,120 when compared to those for the past two years, representing an average of 10,500 documents per working day.

The documents received for registration relate to different aspects of operation of a company, including articles of association, notifications of appointments, resignations and changes in particulars of directors and company secretaries, changes of registered office addresses, returns of allotments and annual returns.

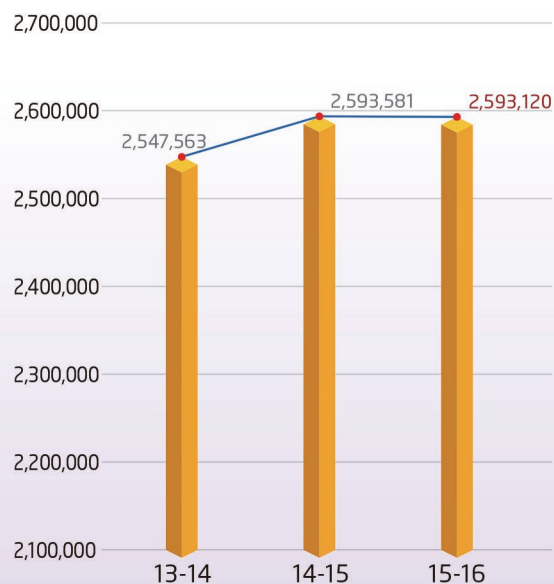

公眾查冊

在二零一五至一六年度，使用本處電子查冊服務查閱文件影像紀錄共有 3,895,298 宗，較前一年增加 3.8%。查閱董事索引的數目共有 340,657 宗，較二零一四至一五年度增加 1.4%，而查閱公司資料的數目共有 238,238 宗，亦錄得 1.7% 輕微增幅。

本處的網上查冊中心繼續是公眾查閱公司資料的最受歡迎渠道，公眾透過網上查冊中心查閱公司資料的比率超過 99%。客戶只須繳付一小筆查冊費後，即可聯線閱覽或下載公司資料及已登記文件的數碼影像紀錄。網上查冊中心設有信用卡或繳費靈網上服務的付款方式，方便客戶以電子方式繳付查冊費用。此外，客戶亦可訂購文件影像紀錄或報告的經核證副本，並選擇以郵遞或速遞方式收取，或親自到本處的公眾查冊中心領取。

Public Searches

In 2015-16, a total of 3,895,298 searches of document image records were conducted using the Registry's electronic search services, representing an increase of 3.8 per cent from the previous year. The number of searches of the Directors' Index was 340,657, an increase of 1.4 per cent over 2014-15. Searches of company particulars also slightly increased by 1.7 per cent to 238,238.

The Registry's Cyber Search Centre ("CSC") continues to be the most popular channel for conducting company searches and over 99 per cent of company searches were made through the CSC. With the payment of a small fee, customers can view or download particulars of companies and digitised image records of documents registered with the Registry. Credit card payment or PPS by Internet are in place to facilitate electronic payment of search fees. Certified true copies of document image records or reports can be ordered and delivered to customers by post or courier or collected in person at the Registry's Public Search Centre.

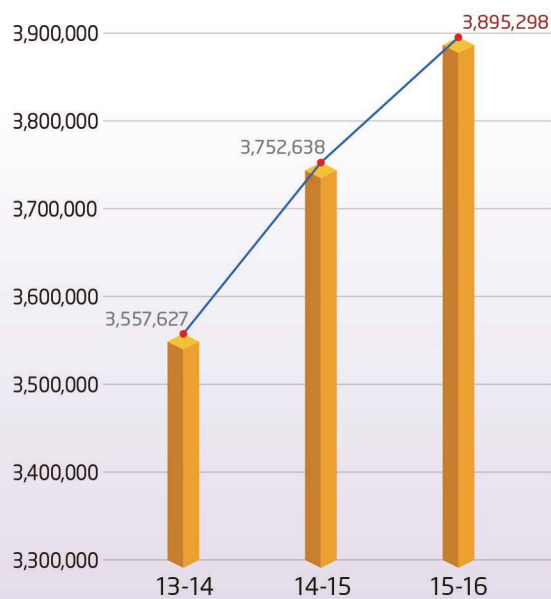

除網上查冊中心外，公司查冊流動版服務是本處提供的另一個便利途徑，讓公眾可使用智能手機及流動裝置查閱公司資料。

Customers can conduct searches as registered online users by payment of an annual fee or as unregistered online users. Registered online users can enjoy lower rates for searching company information. They can also enjoy the convenience of having the search fees deducted from their prepaid accounts and receiving periodical reports on their search activities.

In addition to the CSC, the Company Search Mobile Service ("CSMS") is provided as an additional and convenient means for the public to search company information on their smartphones and mobile devices.

在二零一五至一六年度，交付本處登記的公司押記有 19,933 份，較前一年輕微下跌 5.2%，與公司註冊成立數目的跌幅相若。平均每個工作日交付本處登記的押記有 81 份，當中約有三分之二與房地產有關。

財務表現

財務目標

自前立法局於一九九三年八月一日通過決議成立公司註冊處營運基金，公司註冊處一直按照商業原則，在財政自給的基礎上運作。《營運基金條例》（第 430 章）規定，營運基金的收入必須足以支付提供服務的一切開支，所運用的固定資產平均淨值亦須取得合理回報，而財政司司長將二零一五至一六年度的合理回報率釐定為 6.7%。

Registration of Charges

In 2015-16, 19,933 company charges were received for registration. This reflected a moderate decrease of 5.2 per cent from the previous year, similar to the drop in the number of companies incorporated. An average of 81 charges was registered every working day and about two-thirds of them related to landed property.

Financial Performance

Financial Objectives

Since its establishment as a trading fund on 1 August 1993 by a resolution of the Legislative Council ("LegCo"), the Companies Registry has been operating under commercial principles on a self-financing basis. The Trading Funds Ordinance (Cap. 430) stipulates that a trading fund should meet expenses incurred in the provision of services out of its income and achieve a reasonable return on the average net fixed assets employed, being 6.7 per cent for 2015-16 as set by the Financial Secretary.

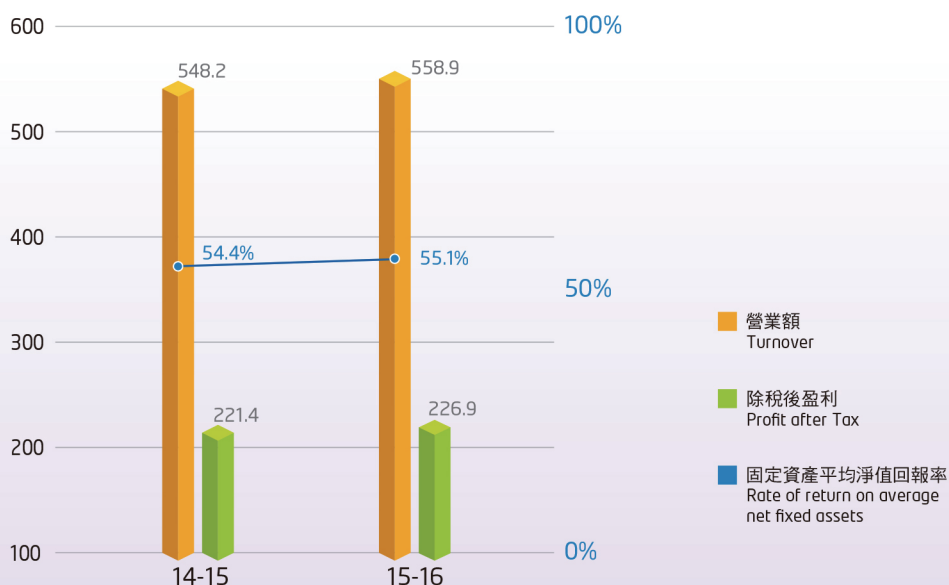

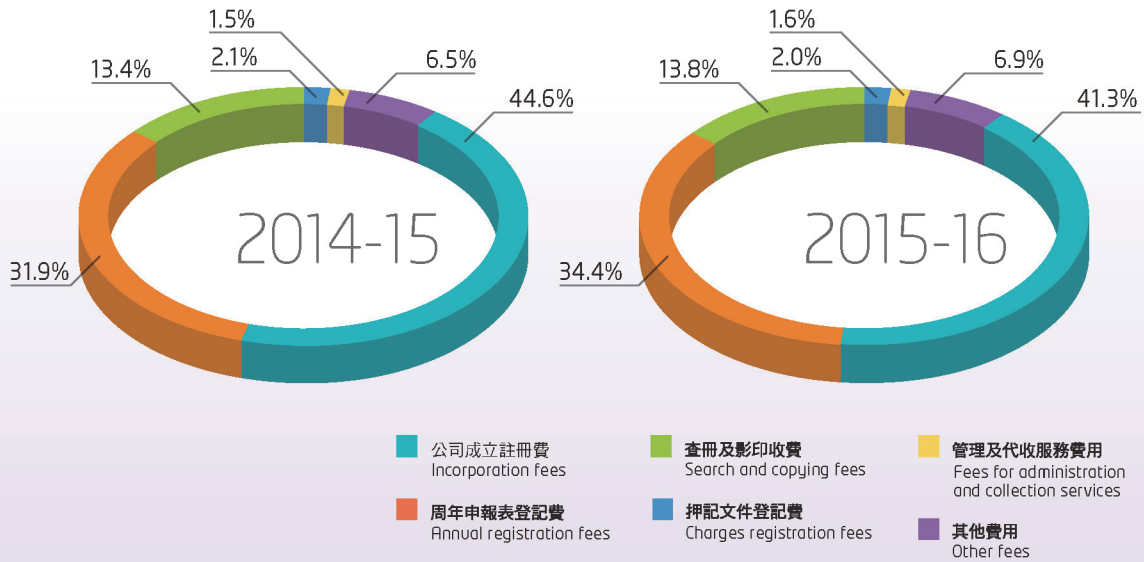

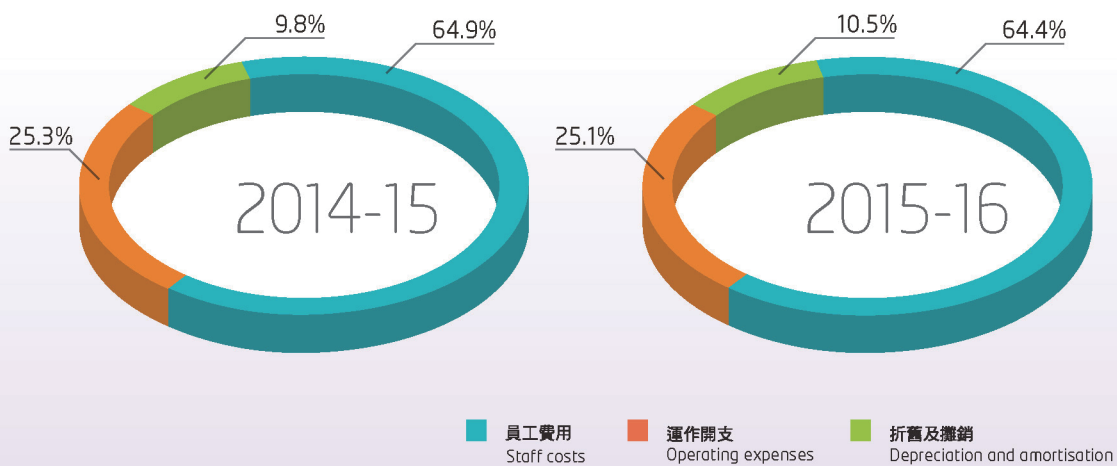

業務回顧與分析

財政檢討

本處在二零一五至一六年度の財務表現保持平穩，營業額為 5 億 5,890 萬元，較二零一四至一五年度輕微上升 2.0%。而開支為 3 億 1,560 萬元，錄得 5.2% 溫和增幅，主要原因是員工費用、運作開支及折舊費用有所增加。本年度的除稅後盈利為 2 億 2,690 萬元，增幅達 2.5%。

本處的收入主要來自新公司註冊成立、周年申報表登記和公司資料查冊等業務，該等業務佔了本處總收入約 90%。在二零一五至一六年度，本處收取的公司成立註冊費，較前一年下跌 5.6%，但周年申報表登記費及查冊費所帶來的收入分別上升 9.8% 及 4.8%，遠遠抵銷了上述跌幅。整體而言，二零一五至一六年度の總營業額錄得 2.0% 輕微增幅。

本處多年來一直能夠達致所訂的財務目標，並維持足夠儲備以應付可持續發展的需要。本處的財務狀況依然十分健全，負債主要包括員工所積存假期的貨幣化價值、網上查冊中心及「註冊易」登記用戶的預付款項、稅款及應計支出。這穩健的財務狀況使本處得以進一步籌劃未來，並推展多項提升服務的措施，以配合多元化的營商環境及科技的迅速發展。

未來展望

根據預測，未來數年本地及外圍經濟環境仍然不明朗，增長動力預料仍會緩慢不均，下行風險突出。在上述背景下，本處預期在二零一六至一七年度，全年營業額只有輕微增長，而這增長會是因公司註冊成立、提交周年申報表及進行公司查冊的數目增加所致。與此同時，預期通脹會令運作成本增加而抵

Financial Review

The financial performance was steady in 2015-16. Turnover was slightly up by 2.0 per cent to \$558.9 million, as compared with 2014-15, whereas expenditure rose mildly by 5.2 per cent to \$315.6 million, mainly due to increase in staff costs, operating expenses and depreciation charges. The profit after tax for the year increased by 2.5 per cent to \$226.9 million.

The Registry mainly generates its income from incorporation of new companies, registration of annual returns and search for company information. These activities together account for about 90 per cent of the Registry's total revenue. The amount of incorporation fees collected in 2015-16 recorded a drop of 5.6 per cent from the previous year, which was more than compensated by the increases in revenue from annual registration fees and search fees of 9.8 per cent and 4.8 per cent respectively. In overall terms, the total turnover grew by a small margin of 2.0 per cent in 2015-16.

The Registry has been able to meet its financial objectives over past years and maintain sufficient reserve to support its ongoing development needs. The financial position of the Registry remains strong with its liabilities mainly consisted of the monetised value of the untaken leave of staff, prepayments from registered users of Cyber Search Centre and e-Registry, taxation and accrued expenses. Taking into account this healthy financial position, the Registry is able to plan further ahead and pursue various service enhancement initiatives to cope with the dynamic business environment and rapid technological advancement.

Future Outlook

It is forecast that uncertainties in the local and external economic environments will linger on in the coming years. Growth momentum is expected to remain slow and uneven with considerable downside risks. Against the above backdrop, we expect only a mild increase in the annual turnover for 2016-17 arising from increases in the number of companies incorporated, annual returns filed and company searches conducted. At the same

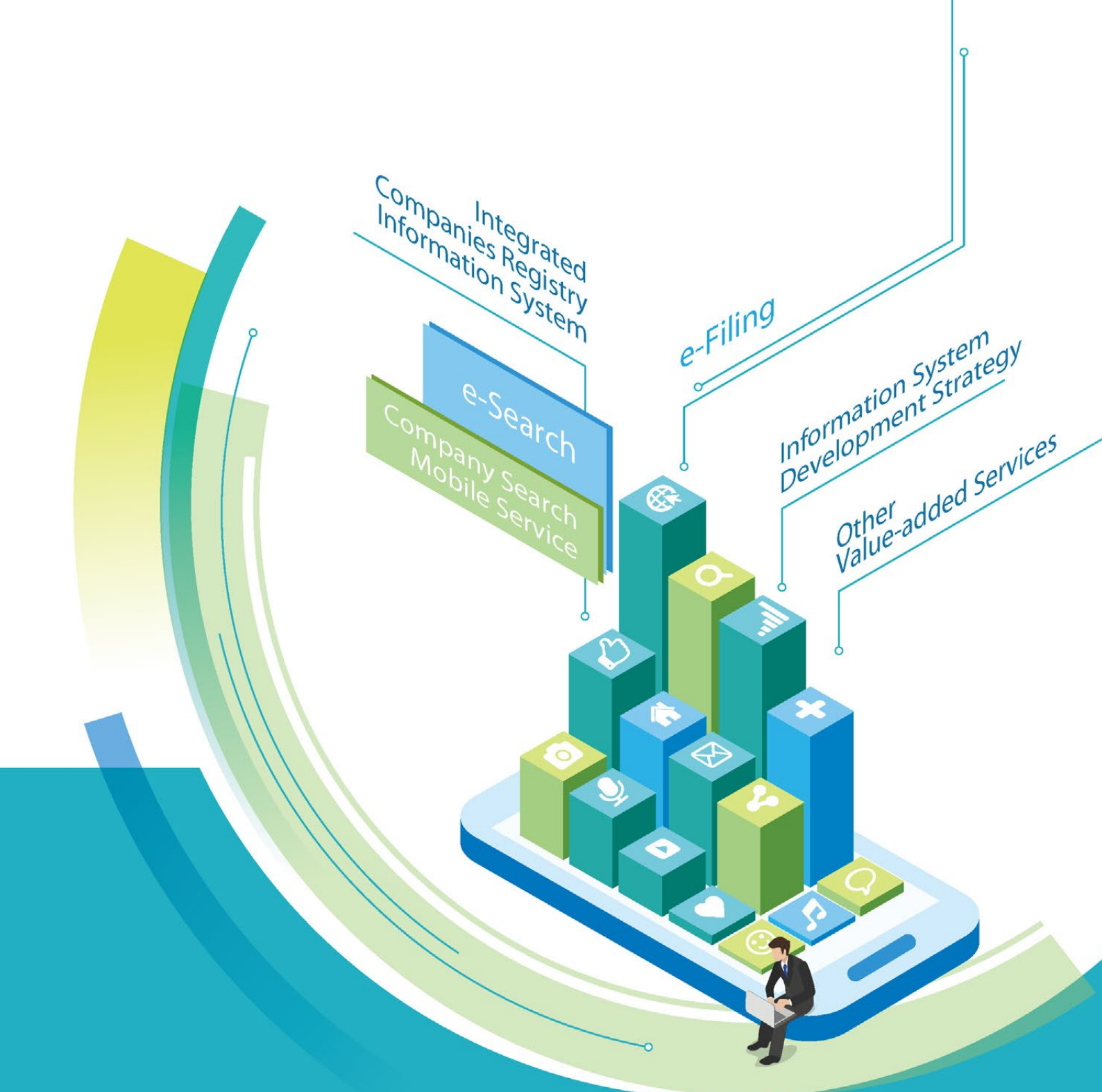

由於本處的業務很大程度依賴公司活動，而後者又較易受全球和本地經濟波動所影響，本處在財務策劃方面需要維持審慎態度，並會嚴格監控資源的運用。就中期而言，本處會保持彈性，不斷努力維持穩健的財務狀況，以促進長遠的可持續發展，同時保持優質服務。本處計劃在未來五年全面翻新現時的資訊科技系統（「公司註冊處綜合資訊系統」），並設立新一代的資訊科技基礎設施，由於當中涉及龐大的資本承擔，維持本處的財務狀況穩固以落實該等措施，尤其重要。

time, operating costs are expected to increase due to inflation to offset the increase in income, leading to a steady outturn for 2016-17.

As the Registry's business is largely reliant on company activities which are vulnerable to global and local economic fluctuations, we need to stay prudent in financial planning and will apply strict control over the use of resources. In the medium term, the Registry will stay resilient and constantly strive to preserve a robust financial position for supporting its long term sustainable development whilst maintaining the high quality of service. We are planning to have a complete revamp of the Registry's existing information technology system (the Integrated Companies Registry Information System) and establish a new generation IT infrastructure in the next five years which would involve huge capital commitments. It is important to maintain our financial stability to cope with these initiatives.





可持續發展創新猷 Innovate for Sustainable Development

新《公司條例》的實施情況

新《公司條例》（香港法例第 622 章）（下稱「新條例」）為在香港註冊成立和營運的公司訂立了新的企業監管制度，藉此達致四大目的，就是加強企業管治、方便營商、確保規管更為妥善，以及使香港的公司法例現代化。新條例已訂立多項措施，藉以簡化法定程序、減輕公司的合規成本，以及照顧中小企的需要。

二零一五至一六年度是實施新條例的第二年。新條例的實施情況十分順利，商界廣泛採用了其中方便營商及有助節省成本的新措施。達標情況從下列的統計數字可見一斑：

- 以電子方式成立的新公司約有 59% 採納了本處在「註冊易」(www.eregistry.gov.hk) 提供的組織章程細則範本；
- 在 182 間減少股本的公司中，有 180 間採用不經法院的替代程序；
- 在本處接獲把公司恢復列入公司登記冊的申請中，有 358 份申請使用以行政方式恢復公司註冊的程序，約佔了恢復公司註冊申請總數的 56%；及
- 有 29 個公司集團透過不經法院的新程序進行了合併。

開放式基金型公司

目前，新條例對公司減少股本設有種種限制，因此，開放式投資基金只可在香港法例下以單位信託的形式成立，而不得以公司形式成立。為了提供法律框架以便把開放式基

Implementation of the New Companies Ordinance

The new Companies Ordinance ("CO"), Chapter 622 of the Laws of Hong Kong, introduced a new corporate regulatory regime for the incorporation and operation of companies in Hong Kong to achieve four main objectives - enhance corporate governance, facilitate business, ensure better regulation and modernise Hong Kong's company law. A number of measures have been introduced under the new CO to simplify statutory procedures, reduce the compliance costs of companies and cater for the needs of small and medium-sized enterprises.

2015-16 marked the second year of the implementation of the new CO. Operation under the new regime has been very smooth, with the business community widely adopting the new initiatives which aim to facilitate business and save costs. The following are some statistics for the year which exemplify the achievement of the objectives:

- around 59% of the new companies incorporated electronically adopted the sample articles of association provided at the e-Registry (www.eregistry.gov.hk);
- 180 out of 182 companies which reduced their capital made use of the alternative court-free procedure;
- 358 applications for restoration of companies to the Companies Register using the administrative restoration procedures were received, which represented about 56% of the total number of applications for company restoration; and
- 29 groups of companies amalgamated through the new court-free procedure.

Open-ended Fund Companies

Currently, an open-ended investment fund may be established under the laws of Hong Kong in the form of a unit trust, but not in corporate form owing to various restrictions on capital reduction under the CO. To provide for a legal framework to introduce a new

金型公司的新結構引入香港，政府當局於二零一六年一月把《2016年證券及期貨（修訂）條例草案》提交立法會審議。該條例草案已於二零一六年六月二日經立法會通過，而當《證券及期貨條例》所需制訂的附屬法例獲通過成為法例後，新制度便會開始實施。

由於開放式基金型公司會以投資基金工具的形式成立，因此證券及期貨事務監察委員會將擔任開放式基金型公司的主要監管機構，而公司註冊處將會負責執行開放式基金型公司成立為法團的登記工作，以及相關法定企業文件的存檔工作。運作細則及各項程序事宜會在證券及期貨事務監察委員會根據《證券及期貨條例》制訂的新附屬法例中訂明。

善用創新科技提升服務

為達致「受世界認同為卓越的公司註冊處，為社會提供優質服務」的理想，本處一向領先應用創意和科技來拓展電子服務，藉以方便營商和提高工作效率。此舉有助鞏固香港作為主要國際商業和金融中心的地位。

公司註冊處綜合資訊系統

「公司註冊處綜合資訊系統」（下稱「綜合系統」）最初於二零零五年推出，用以取代以前零散的操作系統。自此，該系統成為本處核心的資訊科技系統，為客戶提供便捷及優質的電子服務。多年來，本處不斷為綜合系統進行提升工程，藉以落實法例和程序上的改變，以及配合一日千里的科技發展。綜合系統現時透過網上查冊中心、公司查冊流動版服務及「註冊易」入門網站，提供多項電子服務。

open-ended fund company (“OFC”) structure in Hong Kong, the Government introduced the Securities and Futures (Amendment) Bill 2016 into the Legislative Council in January 2016. The Bill was passed by the Legislative Council on 2 June 2016 and the new regime will come into operation after the enactment of the necessary subsidiary legislation under the Securities and Futures Ordinance.

Given that OFCs will be set up as an investment fund vehicle, the Securities and Futures Commission will be the primary regulator of OFCs and the Companies Registry will be responsible for the administration and registration of the incorporation documents and the statutory corporate filings of OFCs. The detailed operational and procedural matters will be set out in new subsidiary legislation to be made by the Securities and Futures Commission under the Securities and Futures Ordinance.

Riding with Technology to Enhance Services

To achieve our vision of world-wide recognition as an excellent Companies Registry giving the community a quality service, we have been at the forefront to apply innovative ideas and technology to expand our electronic services to facilitate the conduct of business and enhance work efficiency. This has helped strengthen Hong Kong’s status as a major international commercial and financial centre.

Integrated Companies Registry Information System

The Integrated Companies Registry Information System (“ICRIS”) was first launched in 2005 to replace its former fragmented operating systems. Since then it has been the core information technology (“IT”) system in the Registry to provide efficient, convenient and high quality electronic services to its customers. Over the years, ICRIS has undergone continuous enhancements to implement legislative and procedural changes and to keep pace with the accelerated technological advancement. It now provides a wide range of electronic services through the Cyber Search Centre, the Company Search Mobile Service and the e-Registry portal.



- 電子查冊

本處的網上查冊中心 (www.icris.cr.gov.hk) 全日 24 小時提供的網上查冊服務，方便易用。現時在網上查閱公司資料的比率超過 99%。公眾人士可隨時查閱登記冊內所載的資料，包括公司資料及文件數碼影像紀錄。透過「註冊易」在網上註冊成立的新公司的資料，可在公司註冊成立後隨即讓公眾查閱。

- 公司查冊流動版服務

隨着使用智能手機和流動裝置日益普及，本處積極提升電子查冊服務，於二零一二年推出「公司查冊流動版服務」（下稱「流動版服務」），讓客戶可隨時隨地使用智能手機及流動裝置，在本處的流動網頁 (www.mobile-cr.gov.hk) 查閱公司的基本資料。由於服務深受公眾歡迎，本處於二零一四年年底為該項服務新增更多查冊功能。在二零一五至一六年度，使用流動版服務進行查冊的數目每日超過 9,000 宗。流動版服務不但方便營商，公眾人士更可即時取得最新的公司資料。為了進一步提升電子查冊服務，本處已於二零一六年五月推出全面的流動版服務，藉以涵蓋所有電子查冊服務及功能。

- e-Search

The Registry's Cyber Search Centre ("CSC") (www.icris.cr.gov.hk) which provides user friendly and convenient company search services via the internet operates round-the-clock throughout the year. Over 99 per cent of company searches are now made online through the CSC. Members of the public can readily access information on the Register which includes particulars of companies and digitised image records of documents. Particulars of new companies incorporated online through the e-Registry are available for public inspection immediately upon incorporation.

- Company Search Mobile Service

In recognition of the increasing popularity of smart phones and mobile devices, the Registry took the initiative to enhance its e-Search service. The Company Search Mobile Service ("CSMS") was introduced in 2012 to enable our customers to conduct searches on basic company information anytime and anywhere using their smart phones and mobile devices at our mobile website (www.mobile-cr.gov.hk). The service has been well received and more search functions were added in late 2014. In 2015-16, more than 9,000 company searches are conducted daily at the CSMS. This not only facilitates the conduct of business in Hong Kong but also enables our customers to obtain the most up-to-date company information at their fingertips. To further enhance the e-Search service, the Registry launched a revamped CSMS in May 2016 to cover a full range of search services and functions.

- 電子提交文件服務

自二零一一年起，本處已透過「註冊易」入門網站 (www.eregistry.gov.hk) 提供一站式公司註冊及商業登記服務。「註冊易」是一個綜合電子平台，讓客戶可在網上提交公司註冊成立的申請書及法定文件。「註冊易」多年來陸續推出了多項服務，現時客戶可透過該網站享用全面的電子提交文件服務，包括提交 84 款新《公司條例》及《公司（清盤及雜項條文）條例》所指明的表格。這不單利便公司資料的申報及披露，更能提高公司提交法定文件的效率。為了向公司提供更便捷及可隨時隨地使用的電子提交文件服務，本處現正研發流動版電子表格提交服務，讓客戶可透過其流動裝置填寫並提交較常提交的表格，此項新服務預計將於二零一七年推出。

- 其他增值服務

為了便利公司及其高級人員履行交付周年申報表的責任，本處在「註冊易」為所有本地公司及註冊非香港公司免費提供「周年申報表 e 提示」服務。公司如已在「註冊易」登記成為公司用戶，便會自動收到提示公司提交周年申報表的電子通知書。客戶亦可訂用「監察易」服務，以監察其公司的文件存檔情況，或當其關注的公司的資料有任何變更時，接收電子通知。

資訊系統發展策略

綜合系統已運作超過十年。為配合不斷轉變的業務需要，本處多年來進行了多項重大的系統提升工程。為善用發展一日千里的資訊科技以應付本處的業務需要，本處於二零一五年年初委託顧問公司進行「部門資訊科技規劃」研究，全面檢討本處的資訊科技系統及相關的基礎設施，協助本處制訂

- e-Filing

Since 2011, the Registry has been providing a one-stop electronic service for company incorporation and business registration at the e-Registry portal (www.eregistry.gov.hk), which is an integrated electronic platform for online submission of applications for company incorporation and statutory documents. More services have been added over the years and customers can now access a full range of electronic filing service through the e-Registry covering a total of 84 forms specified under the new CO and the Companies (Winding Up and Miscellaneous Provisions) Ordinance. This not only facilitates the reporting and disclosure of company information but also delivers efficiencies for statutory filing. To provide the companies with more convenient e-filing services anywhere anytime, the Registry is developing a Mobile e-Form Filing service by which users can complete and submit the commonly filed forms through their mobile devices. This new service is expected to be rolled out in 2017.

- Other Value-added Services

To facilitate companies and their officers to comply with their obligations in delivering annual returns, an Annual Return e-Reminder Service is available at the e-Registry free of charge for all local companies and registered non-Hong Kong companies. Companies which have registered Company User Accounts with the e-Registry will automatically receive electronic notifications for filing annual returns. Customers may also subscribe to the e-Monitor service to monitor the filing position of their own companies or receive electronic notifications about changes of information concerning companies in which they are interested.

Information System Development Strategy

ICRIS has been in operation for more than a decade with a host of major system enhancements implemented over the years to cater for the continuous changes in our business needs. To leverage the rapid advancements in IT for meeting the business needs of the Registry, the Registry commissioned a consultant in early 2015 to conduct a Departmental Information Technology Planning (“DITP”) study encompassing a comprehensive review of the Registry’s IT

未來五年的資訊科技策略，並建議應推行的資訊科技項目。該項研究已於二零一六年年年初完成，顧問公司已向本處建議研發一個全新的一站式電子平台，用以提供優質及個人化的文件登記及查冊服務，新平台將由完善穩健、安全及可擴充的資訊科技基礎設施加以支援。系統提升工程可包括一些個人化服務，例如顯示公司主要詳情的儀錶板、個人化的電子硬碟及新的查冊功能和特點，以方便營商。

前瞻

隨着「部門資訊科技規劃」研究於二零一六年年年初完成，本處已着手計劃落實研究報告的建議，包括在未來五年全面翻新綜合系統及設立新一代資訊科技基礎設施。在綜合系統的翻新工作未完成之前，本處會繼續進行其他系統提升工程，以落實推出流動版電子表格提交服務及開放式基金型公司制度等新措施。

systems and the related infrastructure. The study aimed to help formulate the Registry's IT strategy and recommend IT projects for the next five years. It was completed in early 2016 and the consultant has recommended the Registry to develop a brand new one-stop e-Platform for delivering quality and personalised document registration and searching services, supported by a robust, secure and scalable IT infrastructure. The enhancements may include some personalised services, such as dashboards showing key company information and personal e-Drives and new search functions and features to facilitate businesses.

Looking Ahead

With the completion of the DITP study in early 2016, the Registry has started to plan for the implementation of the proposals recommended in the study, which include a complete revamp of ICRIS and the establishment of a new generation IT infrastructure in the next five years. Before the completion of the ICRIS revamp, we will continue with other system enhancements to implement new initiatives, including the implementation of the Mobile e-Form Filing Service and the OFC regime.





： 企業管治 Corporate Governance

企業管治政策

作為企業監管機構，本處十分重視良好的企業管治。優良的企業管治不但能提高本處的效率及效能，還能提升公眾對我們的管治能力及誠信的信心和信任。本處相信，透過一個能幹及講求問責的管理委員會、具透明度及適時的匯報系統、完善穩健的內部監控系統、有效的風險管理措施、對企業社會責任的承諾，加上建基於本處員工及客戶的需要和公眾的整體利益的管治方針，可有助達致最高的企業管治標準。為此，本處於二零一二年五月發出了全面的公司註冊處企業管治政策聲明。

Corporate Governance Policy

As a corporate regulator, the Registry acknowledges and attaches great importance to good governance as it affects not only the efficiency and effectiveness of the Registry but also the public's confidence and trust in its capability and integrity. We believe that the highest standards of corporate governance are best fulfilled through a competent and accountable management board, transparent and timely reporting systems, robust internal control systems, effective risk management and commitment to corporate social responsibility, while taking into account the needs of our staff and customers and the public interest as a whole. To this end, the Registry issued a comprehensive Corporate Governance Policy Statement in May 2012.

組織架構

截至二零一六年三月底，本處共有 386 名員工，包括 316 名公務員及 70 名合約員工。

管理委員會及轄下專責委員會

本處已設立管理委員會，作為本處企業管治綱領的核心。委員會負責訂定策略方向，制訂政策及管理本處的業務，目的是實踐本處的理想和使命。

管理委員會由公司註冊處處長領導，成員包括本處全體首長級人員。委員會每月（或因應需要更頻密地）召開會議，監督本處的運作和表現。各委員亦討論、檢討並監察本處的主要措施及業務運作，以確保管理妥善及遵從所有有關規例和既定程序。

管理委員會之下設立了四個專責委員會，各有清晰及特定的職權範圍，負責發展、部門編制、誠信管理及投資策略等重要範疇，為管理委員會提供穩固和專業的支援。這些專責委員會亦會向管理委員會作出建議，以加強本處的企業管治。

規管及問責性

整體工作及業務計劃

本處每年均提交整體工作及業務計劃予財經事務及庫務局局長批核。有關計劃包括年度及中期策略，以達致本處的業務及政策目標。經批核的計劃便會成為衡量本處表現的準則，並據此制訂本處的發展計劃及策略。

Organisation Structure

As at the end of March 2016, the Registry had 386 employees, of whom 316 were civil servants and 70 were contract staff.

Management Board and Committees

At the core of its corporate governance framework, the Registry has set up a Management Board which is responsible for setting strategic directions, formulating policies and managing the Registry's business affairs with a view to achieving its vision and mission.

The Board is headed by the Registrar of Companies and composed of all directorate officers of the Registry. The Board meets every month, and more frequently if necessary, to oversee the operations and performance of the Registry. Members will also discuss, review and monitor the Registry's major initiatives and business operation to ensure proper management of the same and compliance with all relevant regulations and established procedures.

Four dedicated committees covering the crucial areas of development, departmental establishment, integrity management and investment strategies have been set up with clear and specific terms of reference to provide solid and professional support to the Management Board. They also make recommendations to the Board for enhancing the governance of the Registry.

Regulation and Accountability

Corporate and Business Plan

Every year, the Registry submits a Corporate and Business Plan to the Secretary for the Financial Services and the Treasury for approval. It covers both the annual and medium range plans for achieving the Registry's business and policy objectives. The approved plan serves as the benchmark against which the Registry's performance is measured. It also forms the basis for devising the Registry's development plan and strategies.

管理委員會及轄下專責委員會 Board and Committees



報告及審計

本處按照公認會計原則編製周年帳目報表，並由審計署署長審計。按照《營運基金條例》的規定，經審計的帳目報表，連同匯報本處工作表現及成績的年報，每年均須提交立法會省覽。為堅守透明度原則，本處亦會把報告上載至本處網頁供公眾閱覽。

規則與規例

雖然本處是根據《營運基金條例》以營運基金部門運作，但在進行採購及其他財務工作時仍須遵從適用的政府規則及規例行事。為此，本處發出內部運作指引和通告，藉此向員工提供遵從規定方面的指導。

Report and Audit

The Registry compiles annual accounts in accordance with generally accepted accounting principles and the accounts are audited by the Director of Audit. Pursuant to the provisions of the Trading Funds Ordinance, the audited accounts together with an annual report on the Registry's performance and achievements are tabled in the Legislative Council each year. To uphold the principle of transparency, the Registry will also post the reports onto its website for public access.

Rules and Regulations

Although the Registry operates as a trading fund department under the Trading Funds Ordinance, it is still required to follow applicable government rules and regulations when conducting procurement and other financial activities. Internal operational guidelines and circulars are issued to provide guidance to staff members on compliance with these requirements.

誠信管理

本處全力支持政府在香港提倡廉潔風氣及維持廉潔守正的公務員隊伍的工作。本處重視誠信管理，這方面的工作大致涵蓋培育價值信念、制訂和維持員工崇高的廉潔操守、檢討程序及系統、進行培訓、為員工提供指引及執行法定規例和準則。本處頒布了誠信管理計劃，闡述本處的誠信管理行政架構，以及現時為促進員工廉潔奉公、誠信不阿的操守而採取的措施。

Integrity Management

The Registry is dedicated to supporting the Government's sustained efforts to entrench an ethical culture and maintain a clean and honest civil service in Hong Kong. The Registry attaches importance to integrity management, which broadly covers the cultivation of values, setting and maintaining a high standard of probity amongst staff, procedure and system review, conducting training and providing guidance for staff and undertaking enforcement of the requirements/standards set. The Registry has promulgated an Integrity Management Plan which sets out the integrity management administration structure and measures currently in place in the Registry to promote integrity and probity amongst staff.

The Integrity Management Committee is responsible for monitoring the progress of implementation of the Integrity Management Plan and coordinating integrity management initiatives of the Registry. It also makes recommendations for improvement measures in relation to integrity management for consideration by the Registrar of Companies.

危機管理

資訊科技保安

Risk Management

IT Security

The Registry recognises the importance of IT Security in the provision of round-the-clock high quality services to its customers. In view of the rising trend of cyber security threats, we have reviewed the IT security policies to ensure that the policies and procedures are in pace with technological advancements, international developments and industry standards. We also put great emphasis on reinforcing staff awareness on IT security so that with their concerted efforts, our electronic services, including the CSC, e-Registry and CSMS, could be provided on secure, stable and reliable platforms.

In 2015-16, the Registry participated in a government-wide security information audit exercise conducted by the Office of the Government Chief Information Officer. The Registry also joined the Cyber Security Drill carried out by the Cyber Security and Technology Crime Bureau of the Hong Kong Police Force.

Business Continuity Plan

To enable the Registry to make speedy decisions in handling crisis situations which affect the normal delivery of public services, a departmental contingency plan setting out the emergency management and guidelines on emergency response to various crises such as fire, power failure, breakdown of ICRIS, or influenza pandemic has been formulated. The plan aims to enhance the

Engagement with Stakeholders

Performance Pledge

As part of our commitment to providing efficient, cost-effective and quality services to the public, we have introduced performance pledges since the establishment of the Companies Registry Trading Fund in 1993. The Registry publishes its performance targets and results annually and closely monitors the performance and fluctuations in workload. Service standards are reviewed annually, taking into account customers' expectations and comments. In 2015-16, we have more than achieved our performance targets, details of which are set out in Appendix C.

Communication with the Public

The Registry values the needs and expectations of our customers. We have well-established communication channels to collect the views and opinions of different customer groups. Through the Registry's website (www.cr.gov.hk), we inform and update the public on the Registry's core business, changes in legislation, filing requirements and our development programmes. The public can subscribe to the Registry's electronic news service ("e-News service") to receive updates on the Registry's services and new initiatives. An enquiry hotline ((852) 2234 9933) is set up for answering enquiries about the Registry's services round-the-clock. A help desk ((852) 8201 8273) to provide technical advice for using the electronic services of the Registry also operates on a 24-hour basis.

The Registry pays courtesy visits to major customers to promote our services and gather comments to refine our services. To showcase its latest services to the business community, the Registry frequently participates in seminars and activities organised by professional bodies.

Through regular meetings, senior officers of the Registry brief members on the Registry's policies and procedures and gather customers' views with a view to understanding their needs and expectations.

These contacts enable us to exchange ideas and share experience with other registries regarding the provision of company registration services and the development of corporate governance in other jurisdictions, which in turn help us formulate new initiatives and strategies in enhancing the quality of our services.

During the year, delegations from the Registry attended Commemorative Activities in Shanghai to celebrate the 10th Anniversary of the Shanghai/Hong Kong Co-operation and Exchange on Foreign Investment Enterprise Registration, a Technical Workshop on Business e-Registrations and a study visit to the Accounting and Corporate Regulatory Authority in Singapore. In 2015-16, the Registry received visitors and officials from a number of Mainland and overseas authorities.

Human Resource Planning

締造更佳工作環境

Auditor's Responsibility

I conducted my audit in accordance with section 7(5) of the Trading Funds Ordinance and the Audit Commission auditing standards. Those standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the General Manager, Companies Registry Trading Fund, as well as evaluating the overall presentation of the financial statements.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

In my opinion, the financial statements give a true and fair view of the state of affairs of the Companies Registry Trading Fund as at 31 March 2016, and of its results of operations and cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards and have been properly prepared in accordance with the manner provided in section 7(4) of the Trading Funds Ordinance.

1. 總論

前立法局在 1993 年 6 月 30 日根據《營運基金條例》(第 430 章)第 3、4 及 6 條通過決議，在 1993 年 8 月 1 日設立公司註冊處營運基金(「營運基金」)。營運基金為客戶提供服務與設施，以辦理有限公司註冊及登記和查閱公司文件。

2. 主要會計政策

(a) 符合準則聲明

本財務報表是按照香港公認的會計原則及所有適用的香港財務報告準則(此詞是統稱，當中包括香港會計師公會頒布的所有適用的個別香港財務報告準則、香港會計準則及詮釋)編製。營運基金採納的主要會計政策摘要如下。

(b) 編製財務報表的基礎

本財務報表的編製基礎均以原值成本值計量。

編製符合香港財務報告準則的帳目需要管理層作出判斷、估計及假設。該等判斷、估計及假設會影響會計政策的實施，以及資產與負債和收入與支出的呈報款額。該等估計及相關的假設，均按以往經驗及其他在有關情況下被認為合適的因素而制訂。倘若沒有其他現成數據可供參考，則會採用該等估計及假

1. General

The Companies Registry Trading Fund ("the CRTF") was established on 1 August 1993 under the Legislative Council Resolution passed on 30 June 1993 pursuant to sections 3, 4 and 6 of the Trading Funds Ordinance (Cap. 430). The CRTF provides its customers with services and facilities to incorporate companies and to register and examine company documents.

2. Significant accounting policies

(a) Statement of compliance

These financial statements have been prepared in accordance with accounting principles generally accepted in Hong Kong and all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), a collective term which includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"). A summary of the significant accounting policies adopted by the CRTF is set out below.

(b) Basis of preparation of the financial statements

The measurement basis used in the preparation of these financial statements is historical cost.

The preparation of financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets and liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making judgements about carrying values of

(c) 金融資產及金融負債

- (i) 營運基金在成為有關金融工具的合約其中一方之日會確認有關金融資產及金融負債。金融資產及金融負債最初按公平值計量；公平值通常相等於成交價，加上因購買金融資產或產生金融負債而直接引致的交易成本。
- (ii) 營運基金的金融資產包括貸款及應收帳款。貸款及應收帳款為有固定或可以確定的支付金額，但在活躍市場並沒有報價，而且營運基金無意持有作交易用途的非衍生金融資產。貸款及應收帳款採用實際利率法按攤銷成本值扣除任何減值虧損（如有）列帳。

assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

There are no critical accounting judgements involved in the application of the CRTF's accounting policies. There are also no key assumptions concerning the future, or other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities in the next year.

(c) Financial assets and financial liabilities

- (i) The CRTF recognises financial assets and financial liabilities on the date it becomes a party to the contractual provisions of the instrument. Financial assets and financial liabilities are measured initially at fair value, which normally equals to the transaction prices, plus transaction costs that are directly attributable to the acquisition of the financial assets or issue of the financial liabilities.
- (ii) The CRTF's financial assets consist of loans and receivables which are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and which the CRTF has no intention of trading. They are carried at amortised cost using the effective interest method less impairment losses, if any.

貸款及應收帳款的帳面值在每個報告期結束日作出評估，以決定是否有客觀的減值證據。若存在減值證據，虧損以該資產的帳面值與按其原本的實際利率用折現方式計算其預期未來現金流量的現值之間的差額，在全面收益表內確認。如其後減值虧損降低，並證實與在確認減值虧損後出現的事件相關，則該減值虧損在全面收益表內回撥。

金融負債採用實際利率法按攤銷成本值列帳。

The effective interest method is a method of calculating the amortised cost of a financial asset or a financial liability and of allocating the interest income or interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments or receipts through the expected life of the financial instrument or, when appropriate, a shorter period to the net carrying amount of the financial asset or financial liability. When calculating the effective interest rate, the CRTF estimates cash flows considering all contractual terms of the financial instruments but does not consider future credit losses. The calculation includes all fees paid or received between parties to the contract that are an integral part of the effective interest rate, transaction costs and all other premiums or discounts.

The carrying amount of loans and receivables is reviewed at the end of each reporting period to determine whether there is objective evidence of impairment. If any impairment evidence exists, a loss is recognised in the statement of comprehensive income as the difference between the asset's carrying amount and the present value of estimated future cash flows discounted at the asset's original effective interest rate. If in a subsequent period, the amount of such impairment loss decreases and the decrease can be linked objectively to an event occurring after the impairment loss was recognised, the impairment loss is reversed through the statement of comprehensive income.

Financial liabilities are carried at amortised cost using the effective interest method.

(iii) 當從金融資產收取現金流量的合約權屆滿時，或已轉讓該金融資產及其絕大部分風險和回報的擁有權，該金融資產會被註銷確認。當合約指明的債務被解除、取消或到期時，該金融負債會被註銷確認。

(iii) A financial asset is derecognised when the contractual rights to receive the cash flows from the financial asset expire, or where the financial asset together with substantially all the risks and rewards of ownership have been transferred. A financial liability is derecognised when the obligation specified in the contract is discharged or cancelled, or when it expires.

(d) 物業、設備及器材

在 1993 年 8 月 1 日撥給營運基金使用的各項物業、設備及器材，最初的成本值是以以前立法局成立營運基金的決議中所列的估值入帳。至於自 1993 年 8 月 1 日購置的各項物業、設備及器材，則是以購置時的實際直接開支入帳。

(d) Property, plant and equipment

Property, plant and equipment appropriated to the CRTF on 1 August 1993 were measured initially at deemed cost equal to the value contained in the Legislative Council Resolution for the setting up of the CRTF. Property, plant and equipment acquired since 1 August 1993 are capitalised at their costs of acquisition.

(e) 無形資產

無形資產包括購入的電腦軟件牌照及已資本化的電腦軟件程式開發成本值。若電腦軟件程式在技術上可行，而且營運基金有足夠資源及有意完成開發工作，有關的開發費用會被資本化。資本化費用包括直接工資及材料費用。無形資產按成本值扣除累計攤銷及任何減值虧損列帳（附註 2(f)）。

無形資產的攤銷按估計可使用年期（5 年）以直線法列入全面收益表。

(f) 固定資產的減值

固定資產（包括物業、設備及器材和無形資產）的帳面值在每個報告期結束日評估，以確定有否出現減值跡象。倘出現減值跡象，每當資產的帳面值高於其可收回數額時，則有關減值虧損會在全面收益表內確認入帳。資產的可收回數額為其公平值減出售成本與使用值兩者中的較高者。

The land on which the CRTF's buildings are situated as appropriated to the CRTF on 1 August 1993 is regarded as a non-depreciating asset.

Gains or losses arising from the disposal of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the asset, and are recognised in the statement of comprehensive income at the date of disposal.

(e) Intangible assets

Intangible assets include acquired computer software licences and capitalised development costs of computer software programmes. Expenditure on development of computer software programmes is capitalised if the programmes are technically feasible and the CRTF has sufficient resources and the intention to complete development. The expenditure capitalised includes direct labour and cost of materials. Intangible assets are stated at cost less accumulated amortisation and any impairment losses (note 2(f)).

Amortisation of intangible assets is charged to the statement of comprehensive income on a straight-line basis over the assets' estimated useful lives of 5 years.

(f) Impairment of fixed assets

The carrying amounts of fixed assets, including property, plant and equipment and intangible assets, are reviewed at the end of each reporting period to identify any indication of impairment. If there is an indication of impairment, an impairment loss is recognised in the statement of comprehensive income whenever the carrying amount of an asset exceeds its recoverable amount. The recoverable amount of an asset is the greater of its fair value less costs to sell and value in use.

(g) 名義利得稅

- (i) 根據《稅務條例》(第 112 章) 營運基金並無稅務責任，但香港特別行政區政府(政府)要求營運基金須向政府一般收入支付一筆款項以代替利得稅(即名義利得稅)，該款項是根據《稅務條例》的規定所計算。本年度名義利得稅支出包括本期稅款及遞延稅款資產和負債的變動。
- (ii) 本期稅款為本年度對應課稅收入按報告期結束日已生效或基本上已生效的稅率計算的預計應付稅款，並包括以往年度應付稅款的任何調整。
- (iii) 遞延稅款資產及負債分別由可扣稅及應課稅的暫時性差異產生。暫時性差異是指資產及負債在財務報表上的帳面值與其計稅基礎的差異。遞延稅款資產也可由未使用稅務虧損及稅項抵免而產生。

所有遞延稅款負債及所有可能未來會有應課稅溢利而使其能被用以抵銷有關溢利的遞延稅款資產，均予以確認。

遞延稅款的確認金額的計算是根據該資產及負債的帳面值之預期變現或清償方式，按在報告期結束日已生效或基本上已生效的稅率計算。遞延稅款資產及負債均不貼現計算。

(g) Notional profits tax

- (i) The CRTF has no tax liability under the Inland Revenue Ordinance (Cap. 112). However, the Government of the Hong Kong Special Administrative Region ("the Government") requires the CRTF to pay to the General Revenue an amount in lieu of profits tax (i.e. notional profits tax) calculated on the basis of the provisions of the Inland Revenue Ordinance. Notional profits tax expense for the year comprises current tax and movements in deferred tax assets and liabilities.
- (ii) Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the end of the reporting period, and any adjustment to tax payable in respect of previous years.
- (iii) Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purposes and their tax bases. Deferred tax assets also arise from unused tax losses and unused tax credits.

All deferred tax liabilities, and all deferred tax assets to the extent that it is probable that future taxable profits will be available against which the assets can be utilised, are recognised.

The amount of deferred tax recognised is measured based on the expected manner of realisation or settlement of the carrying amount of the assets and liabilities, using tax rates enacted or substantively enacted at the end of the reporting period. Deferred tax assets and liabilities are not discounted.

The carrying amount of a deferred tax asset is reviewed at the end of each reporting period and is reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profit will be available.

(h) 收入的確認

服務收費是在提供服務時確認入帳。利息收入則採用實際利率法按應計的利息確認入帳。

(h) Revenue recognition

Revenue is recognised as services are provided. Interest income is recognised as it accrues using the effective interest method.

(i) 僱員福利

營運基金的僱員包括公務員及合約員工。薪金、約滿酬金及年假開支均在僱員提供有關服務所在年度以應計基準確認入帳。就公務員而言，僱員附帶福利開支包括政府給予僱員的退休金及房屋福利，均在僱員提供有關服務所在年度支銷。

(i) Employee benefits

The employees of CRTF comprise civil servants and contract staff. Salaries, staff gratuities, and annual leave entitlements are accrued and recognised as expenditure in the year in which the associated services are rendered by the staff. For civil servants, staff on-costs, including pensions and housing benefits provided to the staff by the Government, are charged as expenditure in the year in which the associated services are rendered.

The CRTF is a separate accounting entity within the Government established under the Trading Funds Ordinance. During the year, the CRTF has entered into transactions with various related parties, including government bureaux and departments, trading funds and

(k) 等同現金

Cash equivalents are short-term highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition.

(l) 新訂及經修訂香港財務報告準則的影響

(a) Investment policy

To provide an ancillary source of income, surplus cash is placed as fixed-term bank deposits and as placement with the Exchange Fund.

(b) Credit risk

Credit risk is the risk that one party to a financial instrument will fail to discharge an obligation and cause the other party to incur a financial loss.

The CRTF's credit risk is primarily attributable to debtors, bank deposits and placement with the Exchange Fund. The CRTF has a credit policy in place

For the placement with the Exchange Fund, the credit risk is considered to be low.

The maximum exposure to credit risk of the financial assets of the CRTF at the end of the reporting period is equal to their carrying amounts.

(c) Liquidity risk

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities.

The CRTF employs projected cash flow analysis to manage liquidity risk by forecasting the amount of cash required and monitoring the working capital of the CRTF to ensure that all liabilities due and known funding requirements could be met. As the CRTF has a strong liquidity position, it has a very low level of liquidity risk.

(d) Interest rate risk

Interest rate risk refers to the risk of loss arising from changes in market interest rates. This can be further classified into fair value interest rate risk and cash flow interest rate risk.

Fair value interest rate risk is the risk that the fair value of a financial instrument will fluctuate because of changes in market interest rates. Since the CRTF's bank deposits bear interest at fixed rates, their fair

(f) Other financial risk

The CRTF is exposed to financial risk arising from changes in the interest rate on the placement with the Exchange Fund which is determined every January (Note 10). It was estimated that, as at 31 March 2016, a 50 basis point (2015: 50 basis point) increase/decrease in the interest rates for 2015 and 2016, with all other variables held constant, would increase/decrease the profit for the year and reserves by HK\$2.6 million (2015: HK\$0.7 million).
