Introduction

1. Every non-Hong Kong company ***must*** make an annual return which should be filed with the Registrar of Companies once every year. The return should reflect accurately the affairs of the company as at the date of return.
2. Please fill in all particulars and complete all items consistently in either English ***OR*** Chinese. In the case of Chinese, traditional Chinese characters should be used. Please note that handwritten forms will be rejected by the Companies Registry.
3. Please complete the Presenter's Reference. Unless the presenter needs to raise a specific issue for the attention of the Companies Registry, no covering letter is required.

Deadline for Delivery of this Form

4. This form must be submitted to the Companies Registry within 42 days after the most recent anniversary of the date of registration of a non-Hong Kong company. ***Late submission is subject to a higher registration fee.*** Please refer to the information pamphlet 'Price Guide to Main Services' for the correct fee payable.

Signature

5. This form must be signed by a director, secretary, manager or an authorized representative. A form which is not properly signed will be rejected by the Companies Registry. The registration fee payable will be calculated according to the resubmission date of the properly signed form.

Fee

6. This form must be submitted with the correct annual registration fee. A form which is not submitted with the correct fee will be rejected by the Companies Registry. The registration fee payable will be calculated according to the resubmission date of the form.
7. If the form is delivered by post, please send a crossed cheque in Hong Kong Dollars payable to 'Companies Registry'. Please do not send cash.

Company Name (Section 1)

8. The company name should be identical to the name which appears in the Certificate of Registration issued by the Companies Registry. If another name has been adopted under section 337B of the Companies Ordinance, please state the approved name in Section 1.

Principal Place of Business in Hong Kong and Offices in Place of Incorporation (Sections 5 and 6)

9. Please supply the e-mail address of the company, on a voluntary basis, to facilitate electronic communication. If there are any subsequent changes in the e-mail addresses, it would be appreciated if you would notify the Companies Registry by completing Form N9.

Authorized Representative in Hong Kong (Section 8)

10. A non-Hong Kong company registered in Hong Kong must authorize at least one person resident in Hong Kong to accept service of process and notices on behalf of the company. An authorized representative may be a natural person, a firm of solicitors, a solicitor corporation, a firm of certified public accountants (practising) or a corporate practice within the meaning of section 2 of the Professional Accountants Ordinance (Cap. 50) but may not be any other form of body corporate or firm.

17. 如秘書或董事屬法人團體，請申報其註冊辦事處或主要辦事處的地址。
18. 請述明董事的身份。如屬候補董事，請註明獲代替行事的董事姓名或名稱。

帳目 (第 12 項)

19. 如交付的帳目並非正本，則有關帳目的核證副本必須連同本表格一併提交。核證方式應依循《公司(表格)規例》第 3 或 7 條的規定。如該等帳目所用的語文並非英文或中文，則只需交付經核證的英文或中文譯本。核證方式應依循《公司(表格)規例》第 6 或 7 條的規定。
20. 如公司能符合本表格第 12B 項所列兩項條件的任何一項，則無需提交帳目。
