### Notes for Completion of Form N4

#### Introduction

1. Every non-Hong Kong company **must** make an annual return which should be filed with the Registrar of Companies once every year. The return should reflect accurately the affairs of the company as at the date of return.
2. If there has been **no change** in the information required to be contained in Sections 4 to 11 inclusive in the annual return **since the date of the last annual return submitted in full form** (i.e. Form N3), the company may use this form in lieu of Form N3.
3. Please fill in all particulars and complete all items consistently in either English **OR** Chinese. In the case of Chinese, traditional Chinese characters should be used. Please note that handwritten forms will be rejected by the Companies Registry.
4. Please complete the Presentor's Reference. Unless the presentor needs to raise a specific issue for the attention of the Companies Registry, no covering letter is required.

#### Deadline for delivery of this Form

5. This form must be submitted to the Companies Registry within 42 days after the most recent anniversary of the date of registration of a non-Hong Kong company. **Late submission is subject to a higher registration fee.** Please refer to the information pamphlet 'Price Guide to Main Services' for the correct fee payable.

#### Signature

6. This form must be signed by a director, secretary, manager or an authorized representative. A form which is not properly signed will be rejected by the Companies Registry. The registration fee payable will be calculated according to the resubmission date of the properly signed form.

#### Fee

7. This form must be submitted with the correct annual registration fee. A form which is not submitted with the correct fee will be rejected by the Companies Registry. The registration fee payable will be calculated according to the resubmission date of the form.
8. If the form is delivered by post, please send a crossed cheque in Hong Kong Dollars payable to 'Companies Registry'. Please do not send cash.

#### Company Name (Section 1)

9. The company name should be identical to the name which appears in the Certificate of Registration issued by the Companies Registry. If another name has been adopted under section 337B of the Companies Ordinance, please state the approved name in Section 1.

#### Certificate to be given on behalf of the Non-Hong Kong Company (Section 3)

10. The date of the last annual return in full form is the date of the last Form N3 filed with the Companies Registry.

#### Accounts (Section 4)

11. If the accounts being submitted are **not** the originals, they must be certified in accordance with Paragraphs 3 or 7 (as appropriate) of the Companies (Forms) Regulations. If the accounts are **not** in English or Chinese, you need **only** submit a translation in either of these languages certified in accordance with Paragraphs 6 or 7 (as appropriate) of the Companies (Forms) Regulations.

12. All directors of the company are advised to read the latest version of the 'Non-statutory Guidelines on Directors' Duties' published by the Companies Registry and acquaint themselves with the general duties of directors outlined in the Guidelines. ##### 引言

2. 如**自最近一份詳盡周年申報表**(即表格 N3)的日期以來,所有載於該申報表第 4 至 11 項的資料並**無任何改變**,公司可使用本表格代替表格 N3。
3. 請劃一以英文**或**中文申報各項所需資料。如以中文申報,請用繁體字。公司註冊處不接納手寫的表格。
4. 請提供提交人的資料。除非有特別事項需要公司註冊處注意,否則無需另加附函。

##### 提交表格的期限

##### 簽署

##### 費用
