Notes for Completion of Form W6

Introduction

In the case of winding up by the court, after the affairs of the company have been completely wound up and the Liquidator has been granted his release by order of the court, the Liquidator may deliver to the Registrar of Companies a Certificate stating that the company has satisfied the above conditions. This form should be used for delivering such a Certificate.
2. Please fill in all particulars and complete all items consistently in either Chinese ***OR*** English. In the case of Chinese, traditional Chinese characters should be used. Please note that handwritten forms will be rejected by the Companies Registry.
3. Please complete the Presentor's Reference. Unless the presentor needs to raise a specific issue for the attention of the Companies Registry, no covering letter is required.

4. This form must be signed by the Liquidator(s). If the Liquidators appointed are Joint Liquidators, this form should be signed by all the Liquidators. A form which is not properly signed will be rejected by the Companies Registry.
