

本處經常與內地及其他司法管轄區保持並加強聯繫,就提供和發展公司註冊服務,以及企業管治事宜,交流意見和經驗,這對於本處日後制訂新的措施和策略,大有裨益。

本處在二零零六至零七年度共接待了15 批訪客,包括內地政府部門和專業團體, 以及斯里蘭卡、越南、馬來西亞中華工 商聯合會、新加坡律政部、澳洲證券及 投資監察委員會和薩摩亞國際財務管理 局的政府官員。 The Registry maintains and develops contacts with the Mainland and other jurisdictions on a regular basis. These contacts enabled us to exchange ideas and share experiences regarding the provision and development of corporate registration services and corporate governance issues and will be very useful for developing new initiatives and strategies in the future.

In 2006-07, the Registry received 15 groups of visitors from government departments and professional bodies from the Mainland and government officials from Sri Lanka, Vietnam, the Associated Chinese Chambers of Commerce and Industry of Malaysia, the Ministry of Law of Singapore, the Australian Securities & Investments Commission of Australia and the Samoa International Finance Authority.

After the Forum, the Registry Manager with a small team from the Registry had useful discussions and experience sharing with the Accounting and Corporate Regulatory Authority of Singapore.

During the year, we organised attachment programmes for government officials from the Mainland — the Registration Bureau of Foreign Invested Enterprises of the State Administration for Industry and Commerce, and the Administration for Industry and Commerce of Shanghai, Hangzhou and Shenzhen. The attachment programmes helped enhance their understanding of the corporate registration system in Hong Kong and the Registry's operations under ICRIS. They also offered a good opportunity for the department's staff to update their knowledge of the corporate registration systems in the Mainland.
