- 1. 任何人可藉向開放式基金型公司發出書面通知,辭去該公司核數師的職位,該通知 須隨附《證券及期貨(開放式基金型公司)規則》(「該規則」)第144條規定須給予的 情況陳述。公司須在自收到該規則第138(1)條所指的辭職通知的日期起計的15日 內,以本表格將述明該事實的通知,交付公司註冊處處長(「處長」)登記。
- 2. 請劃一以中文或英文申報各項所需資料。如以中文申報,請用繁體字。以手寫方式填寫的表格或不會被公司註冊處接納。
- 3. 請提供提交人資料。除非有特別事項需要公司註冊處注意,否則無須另加附函。

Notes for Completion of Form OFCA2

Introduction

- 1. A person may resign from the office of auditor of an open-ended fund company by giving the company a notice in writing that is accompanied by a statement of circumstances required under rule 144 of the Securities and Futures (Open-ended Fund Companies) Rules. Within 15 days beginning on the date on which a company receives a notice of resignation under rule 138(1), the company must deliver to the Registrar of Companies (the Registrar) for registration, a notice in this form of that fact.
- 2. Please fill in all particulars and complete all items consistently in either Chinese or English. Traditional Chinese characters should be used if the form is completed in Chinese. Please note that handwritten forms may be rejected by the Companies Registry.
- 3. Please complete the Presentor's Reference. Unless the presentor needs to raise a specific issue for the attention of the Companies Registry, no covering letter is required.
- 4. This form can be delivered by post or in person to "The Companies Registry, 14th floor, Queensway Government Offices, 66 Queensway, Hong Kong". If the form is delivered by post but the Registrar has not received it, the form will not be regarded as having been delivered to the Registrar in satisfaction of the relevant provision of the Securities and Futures (Open-ended Fund Companies) Rules.

5. This form must be signed by a director. A form which is not properly signed will be rejected by the Companies Registry.

6. Please provide the business registration number (i.e. the first 8 digits of the Business Registration Certificate number) issued by the Business Registration Office of the Inland Revenue Department. The numbers after [-] are not required.
