- 1. 本表格是用以通知公司註冊處處長(「處長」)有關開放式基金型公司的非香港居民董事的法律程序文件代理人的詳情更改。如有關詳情有任何更改,該公司須在該項更改後的 15 日內,將更改的通知以本表格交付處長登記。
- 2. 根據《證券及期貨(開放式基金型公司)規則》(「該規則」)第102(1)條,開放式基金型公司的非香港居民董事須有一名法律程序文件代理人。法律程序文件代理人可以是
 - (a) 通常住址在香港的個人;
 - (b) 一間公司;
 - (c) 一間律師行;或
 - (d) 一間《會計及財務匯報局條例》(第588章)第2(1)條所界定的會計師事務所。

For the purposes of rule 102(6) of Securities and Futures (Open-ended Fund Companies) Rules (Cap. 571AQ)

Notes for Completion of Form OFCPA1

Introduction

- 1. This form should be used to notify the Registrar of Companies (the Registrar) of any change in particulars of a non-resident director's process agent of an open-ended fund company. This form should be delivered to the Registrar for registration within 15 days after the change in the particulars.
- 2. Pursuant to rule 102(1) of the Securities and Futures (Open-ended Fund Companies) Rules (the Rules), a non-resident director of an open-ended fund company must have a process agent. A process agent can either be
 - (a) an individual whose usual residential address is in Hong Kong;
 - (b) a company;
 - (c) a firm of solicitors; or
 - (d) a CPA firm as defined by section 2(1) of the Accounting and Financial Reporting Council Ordinance (Cap. 588).
- 3. Please use the appropriate form to report the following changes —

- **4.** Please fill in all particulars and complete all items consistently in either Chinese or English. Traditional Chinese characters should be used if the form is completed in Chinese. Please note that handwritten forms may be rejected by the Companies Registry.
- **5.** Please complete the Presentor's Reference. Unless the presentor needs to raise a specific issue for the attention of the Companies Registry, no covering letter is required.
- **6.** This form can be delivered by post or in person to "The Companies Registry, 14th floor, Queensway Government Offices, 66 Queensway, Hong Kong". If the form is delivered by post but the Registrar has not received it, the form will not be regarded as having been delivered to the Registrar in satisfaction of the relevant provision of the Rules.

Signature

7. This form must be signed by a director. A form which is not properly signed will be rejected by the Companies Registry.

Business Registration Number

8. Please provide the business registration number (i.e. the first 8 digits of the Business Registration Certificate number) issued by the Business Registration Office of the Inland Revenue Department. The numbers after [-] are not required.

Change in Particulars of Process Agent of Non-resident Director (Section 2)

- **9.** Please state the name(s) of the director(s) for whom the process agent is appointed.
- **10.** Please state only the <u>new particulars</u> of the process agent in the appropriate box(es) provided and specify the effective date of change in the corresponding box. There is no need to state those particulars which remain unchanged.
- **11.** Please provide the address of the process agent in *Hong Kong*
 - (a) If the process agent is an individual, his / her usual residential address should be given.
 - (b) If the process agent is a company, the address of the company's registered office should be given.
 - (c) If the process agent is a partnership, the principal place of business of the partnership should be given.
