#### 引言

- 1. (a) 如任何人取得委任開放式基金型公司財產的接管人或經理人的命令,或如任何人 根據任何文書所載的權力委任上述接管人或經理人,該人須在該項命令或根據該 權力作出委任(視情況所需而定)的日期後的7日內,將一份包含關於該事實的陳述 的通知,以本表格交付公司註冊處處長(「處長」)登記。
  - (b) 如任何人以承按人身分,就開放式基金型公司財產行使管有權,該人須在開始行使 管有權的日期後的7日內,將一份包含關於該事實的陳述的通知,以本表格交付處 長登記。
- 2. 請劃一以中文或英文申報各項所需資料。如以中文申報,請用繁體字。以手寫方式填寫的表格或不會被公司註冊處接納。
- 3. 請提供提交人資料。除非有特別事項需要公司註冊處注意,否則無須另加附函。
- 4. 你可郵寄本表格到「香港金鐘道 66 號金鐘道政府合署 14 樓公司註冊處」,或親身到上址交付。如以郵寄方式交付表格而處長並沒有收到該表格的話,則該表格不會視作 曾為遵從《證券及期貨(開放式基金型公司)規則》中有關條文的規定而交付處長。

#### 費用

#### 簽署

  - (b) 如本表格是用以申報承按人行使財產管有權,則表格必須由第3A項所述的承按人簽署。

如委任人或承按人屬法人團體,本表格必須由其一名董事、公司秘書或授權代表簽署。 如委任人或承按人屬自然人,則本表格必須由委任人或承按人親自簽署,或由其授權 代表簽署。

公司註冊處不接納未簽妥的表格。

For the purposes of rules 174(1) and 174(3) of Securities and Futures (Open-ended Fund Companies) Rules (Cap. 571AQ)

#### **Notes for Completion of Form OFCRC1**

#### Introduction

- 1. (a) If a person obtains an order for the appointment of a receiver or manager of the property of an openended fund company, or appoints such a receiver or manager under the powers contained in an instrument, the person must, within 7 days after the date of the order or of the appointment under those powers (as the case requires), deliver to the Registrar of Companies (the Registrar) for registration, a notice including a statement of that fact in this form.
  - (b) If a person enters into possession of the property of an open-ended fund company, as mortgagee, the person must, within 7 days after the date of entering into possession, deliver to the Registrar for registration, a notice including a statement of that fact in this form.
- 2. Please fill in all particulars and complete all items consistently in either Chinese or English. Traditional Chinese characters should be used if the form is completed in Chinese. Please note that handwritten forms may be rejected by the Companies Registry.
- **3.** Please complete the Presentor's Reference. Unless the presentor needs to raise a specific issue for the attention of the Companies Registry, no covering letter is required.
- 4. This form can be delivered by post or in person to "The Companies Registry, 14th floor, Queensway Government Offices, 66 Queensway, Hong Kong". If the form is delivered by post but the Registrar has not received it, the form will not be regarded as having been delivered to the Registrar in satisfaction of the relevant provision of the Securities and Futures (Open-ended Fund Companies) Rules.

#### Fee

5. This form must be delivered with the correct fee. A form which is not delivered with the correct fee will be rejected by the Companies Registry. If the fee is paid by cheque, the cheque should be crossed and issued in Hong Kong Dollars payable to 'Companies Registry'. Please do not send cash.

#### **Signature**

- **6.** (a) If this form is to give notice of appointment of receiver or manager, it must be signed by the mortgagee or the person who obtained the court order stated in Section 2A of this form (collectively referred to as the appointor).
  - (b) If this form is to give notice of mortgagee entering into possession of property, it must be signed by the mortgagee named in Section 3A of this form.

If the appointor or mortgagee is a body corporate, this form must be signed by a director, company secretary or an authorized representative. If the appointor or mortgagee is a natural person, this form must be signed by the appointor or mortgagee personally or by his or her authorized representative.

A form which is not properly signed will be rejected by the Companies Registry.

#### **Business Registration Number**

7. Please provide the business registration number (i.e. the first 8 digits of the Business Registration Certificate number) issued by the Business Registration Office of the Inland Revenue Department. The numbers after [-] are not required.

#### Mode of Appointment of Receiver or Manager (Section 2A)

**8.** If the receiver or manager is appointed by a court order, please state the particulars of the court order. Presentors need not deliver a copy of the court order to the Companies Registry.

#### Particulars of Receiver or Manager (Section 2C)

- **9.** Please provide the full address of the receiver or manager. 'Care of' addresses and post office box numbers are not acceptable.
- 10. Please provide the email address of the receiver or manager, if any, to facilitate electronic communication. If there are any subsequent changes in the email address, please notify the Companies Registry by completing Form OFCRC3.
- 11. The Hong Kong Identity Card number or, in the absence of a Hong Kong Identity Card, the number and issuing country / region of the passport of the receiver or manager should be given. If he or she holds neither a Hong Kong Identity Card nor a passport, please state 'Nil' in the boxes provided.

#### Particulars of Mortgagee Entering into Possession of Property (Section 3A)

- **12.** The Hong Kong Identity Card number or, in the absence of a Hong Kong Identity Card, the number and issuing country / region of the passport of the mortgagee who is a natural person should be given. If he or she holds neither a Hong Kong Identity Card nor a passport, please state 'Nil' in the boxes provided.
- **13.** If there has been a change of mortgagee, please fill in the date on which the current mortgagee became entitled to the mortgage in the box provided.
- **14.** Please provide the full address of the mortgagee. 'Care of' addresses and post office box numbers are not acceptable. If the mortgagee is a body corporate, please provide the address of the registered or principal office.
- **15.** Please supply the email address of the mortgagee, if any, to facilitate electronic communication. If there are any subsequent changes in the email address, please notify the Companies Registry by completing Form OFCRC3.
