- 1. (a) 如任何人經法院命令或根據任何文書所載的權力獲委任為開放式基金型公司財產的接管人或經理人,該人須在停任接管人或經理人的日期後的 7 日內,將一份包含關於停任一事的陳述的通知,以本表格交付公司註冊處處長(「處長」)登記。
 - (b) 如任何人以承按人身分,不再管有開放式基金型公司財產,該人須在不再管有該財產後的7日內,將關於該事實的陳述,以本表格交付處長登記。
- 2. 請劃一以中文或英文申報各項所需資料。此外,所選用的語文<u>必須</u>與有關的表格 OFCRC1 所用的語文相同。如以中文申報,請用繁體字。以手寫方式填寫的表格或不會 被公司註冊處接納。
- 3. 請提供提交人資料。除非有特別事項需要公司註冊處注意,否則無須另加附函。

Notes for Completion of Form OFCRC2

Introduction

- 1. (a) A person appointed by a court order or under the powers contained in an instrument as the receiver or manager of the property of an open-ended fund company must, within 7 days after the date of his / her ceasing to act as receiver or manager, deliver to the Registrar of Companies (Registrar) for registration, a notice including a statement of the cessation in this form.
 - (b) If a person, in the capacity of a mortgagee, goes out of possession of the property of an open-ended fund company, the person must, within 7 days after going out of possession of the property, deliver to the Registrar for registration a notice including a statement of that fact in this form.
- 2. Please fill in all particulars and complete all items consistently in either Chinese or English <u>AND</u> in the same language used in the related Form OFCRC1. Traditional Chinese characters should be used if the form is completed in Chinese. Please note that handwritten forms may be rejected by the Companies Registry.
- **3.** Please complete the Presentor's Reference. Unless the presentor needs to raise a specific issue for the attention of the Companies Registry, no covering letter is required.
- **4.** This form can be delivered by post or in person to "The Companies Registry, 14th floor, Queensway Government Offices, 66 Queensway, Hong Kong". If the form is delivered by post but the Registrar has not received it, the form will not be regarded as having been delivered to the Registrar in satisfaction of the relevant provision of the Securities and Futures (Open-ended Fund Companies) Rules.

Signature

- **5.** (a) If this form is to give notice of cessation of appointment of receiver or manager, it must be signed by the person named in Section 2A of this form who ceased to act as receiver or manager personally.
 - (b) If this form is to give notice of mortgagee going out possession of property, it must be signed by the mortgagee named in Section 3A of this form. If the mortgagee is a body corporate, this form must be signed by a director, company secretary or an authorized representative. If the mortgagee is a natural person, this form must be signed by the mortgagee personally or by his or her authorized representative.

A form which is not properly signed will be rejected by the Companies Registry.
