#### Introduction

- 1. This form should be used to notify the Registrar of Money Lenders ("the Registrar") of the changes in particulars of appointed third party of licensed money lender.
- 2. An appointed third party of a licensed money lender is a person appointed by the licensed money lender for or in relation to granting a loan to any intending borrower or any specified class of intending borrowers, whether as to the procuring, negotiation, obtaining, application, guaranteeing or securing the repayment of such a loan.
- 3. Please use the appropriate form to report the following changes—

- **8.** Please state only the <u>new particulars</u> of the appointed third party in the appropriate box(es) provided. There is no need to state those particulars which remain unchanged.
- 9. (a) If the details of change involve Hong Kong Identity Card number or issuing country/region and number of passport held by an appointed third party who is an individual, the appointed third party may present his/her original identification document in person at the Money Lenders Section for checking. Alternatively, the licensed money lender may submit a copy of the identification document of the appointed third party together with this form.
  - (b) If you submit this form electronically through the Companies Registry's e-Services Portal to report the change in Hong Kong Identity Card number or issuing country/region and number of passport held by the appointed third party and have selected in the form that the appointed third party will present his/her original identification document in person at the Money Lenders Section, the form will be processed after completion of checking of the identification document.
- 10. If it is required to provide the business registration number, please provide the business registration number (i.e. the first 8 digits of the Business Registration Certificate number) issued by the Business Registration Office of the Inland Revenue Department. The numbers after [-] are not required. For companies incorporated/registered on or after 27 December 2023, the business registration number is also adopted as the "No." on the "Certificate of Incorporation" or "Certificate of Registration of Non-Hong Kong Company" issued by the Companies Registry.

#### **Personal Information Collection Statement**

#### **Purpose of Collection**

- 1. Personal data provided in this form to the Registrar of Money Lenders ("the Registrar") will be used by the Registrar for one or more of the following purposes:
  - (a) to process applications for money lenders licences or their renewals under the Money Lenders Ordinance (Cap. 163) and the Money Lenders Regulations (Cap. 163A);
  - (b) to administer the Money Lenders Ordinance (Cap. 163);
  - (c) to enforce relevant provisions of the Money Lenders Ordinance (Cap. 163) (including relevant conditions of the money lenders licences);
  - (d) to make available for public inspection information (containing personal data) registered under the Money Lenders Ordinance (Cap. 163); and
  - to provide copies of any documents containing such personal data to any person subject to payment of a fee.

#### **Classes of Transferees**

2. The personal data collected will be available for public inspection subject to any restriction in law.

#### **Notice**

- 1. The provisions of the Personal Data (Privacy) Ordinance (Cap 486) ("PDPO"), apply to the use of personal data obtained from the public registers maintained by the Registrar. Any person who uses personal data for any purpose other than the purposes stated in the Personal Information Collection Statement or in contravention of the requirements under the PDPO is liable to pay compensation and may be subject to enforcement action under the PDPO.
- 2. Individuals have a right to request access to and correction of his/her personal data held in the public registers maintained by the Registrar pursuant to sections 18 and 22 of the PDPO. Any such request for access to and correction of such personal data may be made to any officer acting for or on behalf of the Registrar at the Companies Registry, 15th Floor, Queensway Government Offices, 66 Queensway, Hong Kong.
