Registration of a Limited Partnership

1. What should I do if I want to register a limited partnership ?

Deliver the following document and fees to the Shroff of the Companies Registry on the 14th floor of the Queensway Government Offices –

- (a) Form 1 – Application for registration of a limited partnership;
- (b) a registration fee of HK\$340; and
- (c) for every HK\$1,000 or part of HK\$1,000 of the sum contributed by each limited partner, a fee of HK\$8.

2. What can I get ?

A Certificate of Registration of a Limited Partnership.

3. How long does it take ?

Normally, the Certificate of Registration of a Limited Partnership can be issued in 5 working days. The presenter of the application will be notified by fax when the certificate is ready for collection. The certificate has to be collected *in person* at the Information Counter of the Money Lenders Section on the 13th floor, Queensway Government Offices.

4. Do I need to file any documents during the continuance of a limited partnership ?

A statement in the prescribed Form 2, specifying the change (if any) in the registered particulars of the limited partnership, is required to be delivered within 7 days to the Registrar of Companies for registration.

5. What are the fees for registering the changes in particulars of a limited partnership ?

(a) For registering a statement of any change	26
(b) For every HK\$1,000 or part of HK\$1,000 of increase of the sum contributed by any limited partner	8
(c) For every HK\$1,000 or part of HK\$1,000 of the sum contributed by any new limited partner	8

6. Where can I obtain the forms ?

You can download Forms 1 and 2 under the “Forms” – “Other Forms” section of the Registry’s website (www.cr.gov.hk).

7. How to inspect the documents filed by a limited partnership ?

You can conduct a search at the Registry’s Cyber Search Centre (www.icris.cr.gov.hk), via our Company Search Mobile Service (www.mobile-cr.gov.hk) or at its Public Search Centre on the 13th floor of Queensway Government Offices upon payment of a fee of HK\$13 for each inspection.
