Registration of a Limited Partnership

1. What should I do if I want to register a limited partnership ?

You can deliver the following document and fees **in person** to the Shroff of the Companies Registry (“the Registry”) on the 14th floor of the Queensway Government Offices, or **through the e-Filing Services of the Registry’s e-Services Portal** (www.e-services.cr.gov.hk) if you are a registered user of the e-Filing Services.

- Form 1 – Application for registration of a limited partnership;
- a registration fee of HK\$340; and
- for every HK\$1,000 or part of HK\$1,000 of the sum contributed by each limited partner, a fee of HK\$8.

2. What can I get ?

A Certificate of Registration of a Limited Partnership.

3. How long does it take ?

Normally, the Certificate of Registration of a Limited Partnership can be issued in 5 working days.

Application delivered in electronic form

The Registry will issue the Certificate in electronic form to the email address of the presenter.

Application delivered in hard copy form

The Registry will notify the presenter by email to collect the Certificate in hard copy form at the Information Counter on 14th Floor, Queensway Government Offices.

4. Do I need to file any documents during the continuance of a limited partnership ?

A statement in the prescribed [Form 2](#), specifying the change (if any) in the registered particulars of the limited partnership, is required to be delivered within 7 days to the Registrar of Companies for registration.

5. What are the fees for registering the changes in particulars of a limited partnership ?

HK\$

- For registering a statement of any change26
- For every HK\$1,000 or part of HK\$1,000 of increase of the sum contributed by any limited partner..... 8
- For every HK\$1,000 or part of HK\$1,000 of the sum contributed by any new limited partner.....8

6. Where can I obtain the forms ?

For paper submission, you can download Forms 1 and 2 under the “Forms” – “Other Forms” section of the Registry’s website (www.cr.gov.hk).

For electronic submission, please visit the e-Filing Services of the Registry’s e-Services Portal.

7. How to inspect the documents filed by a limited partnership ?

You can conduct a search through the e-Search Services of the e-Services Portal or at the Registry’s e-Services Centre on the 13th floor of Queensway Government Offices upon payment of a fee of HK\$13 for each inspection.
