## COMPANIES ORDINANCE

## (Chapter 622 of the Laws of Hong Kong)

In exercise of the power conferred on me under sections 23(1) and 914(6)(a) of the Companies Ordinance (Chapter 622) ('new Companies Ordinance') and section 32 of the Interpretation and General Clauses Ordinance (Chapter 1), I hereby specify the forms mentioned in the first column of the Schedule hereto for use with effect from the commencement of the new Companies Ordinance for the purposes of:—

- (a) the section(s) of the new Companies Ordinance mentioned opposite to the respective entries of the forms in the second column of the Schedule hereto; and
- (b) the section(s), if any, of the Companies Ordinance (Chapter 32) ('existing Companies Ordinance') mentioned opposite to the respective entries of the forms in the third column of the Schedule hereto, which will be repealed upon the commencement of the new Companies Ordinance but will have a continuing effect under Schedule 11 to the new Companies Ordinance or by virtue of section 23 of the Interpretation and General Clauses Ordinance (Chapter 1).
