The Commission will send the relevant documents and fees to the Companies Registry.
- According to sections 5A(1) and 5D(2) of the Business Registration Ordinance (Cap. 310), the non-Hong Kong fund corporation must deliver a Notice to Business Registration Office (IRBR3) and the prescribed business registration fee and levy together with this form. Otherwise, the application will be rejected by the Companies Registry.
- Please fill in all particulars and complete all items consistently in either Chinese or English. Traditional Chinese characters should be used if the form is completed in Chinese. Please note that handwritten forms may be rejected by the Companies Registry.
- 4. Please complete the Presentor's Reference. Unless the presentor needs to raise a specific issue for the attention of the Companies Registry, no covering letter is required. The Companies Registry will notify the presentor by fax to collect the Certificate of Re-domiciliation and Business Registration Certificate for the OFC in person. A written authorization will be required if the presentor sends a representative to collect the certificates.
