COMPANIES REGISTRY EXTERNAL CIRCULAR NO. 3 / 2011

Commemorative Records of Registration

This circular is to announce the issue of Commemorative Records of Registration ("Commemorative Records") by the Companies Registry ("the Registry") with effect from 18 March 2011 (Friday).

- 2. With effect from 18 March 2011, any director of a live local company may apply for a Commemorative Record in respect of the company. Four designs, with options for companies to insert photographs of their own choice, will be available. The Commemorative Record will be provided at a fee of HK\$345.
- 3. Applicants can submit application forms with the required fees to the Public Search Centre of the Registry on the 13th floor of Queensway Government Offices. A specimen of the application form and samples of the Commemorative Records are at **Annexes 1 and 2**. Application forms can be obtained from the Registry's Public Search Centre and can also be downloaded from the "Product" "Other Products" section of the Registry's Cyber Search Centre (www.icris.cr.gov.hk).

- 1. 一間仍在登記冊上的本地公司可申請公司註冊紀念證明書 (「證明書」)。證明書只作展示用途。申請人必須為公司的董事。申請人的個人資料只會用於處理申請。
- 2. 公司註冊處有權接納或拒絕任何申請。申請如不獲接納,公司註冊處會安排退回申 請費用。

證明書一般可於申請獲接納後的3個工作天內發出。如申請費用以支票繳付,證明書會於支票兒現後,即大概5個工作天後發出。

- 3. 證明書只會顯示公司的現用名稱。

Notes

- 1. Any live local company may apply for a Commemorative Record of Registration ("Commemorative Record"). The Commemorative Record is for display purposes only. Applicant must be a director of the company. Personal data of applicants will only be used for processing applications.
- 2. The Companies Registry may accept or reject any application at its sole and absolute discretion. In the event of any unsuccessful application, the Companies Registry will arrange for refund of application fees.

A Commemorative Record will normally be issued in three working days after acceptance of an application. Where application fees are paid by cheque, Commemorative Records will be issued after clearance of cheque in about five working days.

- 3. Only the current name of the company will be shown on the Commemorative Record.
- 4. Sample Commemorative Records are for reference only.
- 5. Applicant who selects Design C or D of the Commemorative Record should submit the application form together with a CD-ROM containing the image file of a photograph in specified format as follows:




