# The New Companies Ordinance (Cap. 622) -Introduction of Electronic Templates of Newly Specified Forms at the e-Registry

This circular announces the introduction of electronic templates of newly specified forms at the e-Registry (<u>www.eregistry.gov.hk</u>) upon the commencement of the new Companies Ordinance, Chapter 622 of the Laws of Hong Kong ("the new CO"), on 3 March 2014.

### e-Registry

2. The Companies Registry ("the Registry") provides electronic services for submission of applications for company and business registration, specified forms and other documents at the 24-hour e-Registry portal. Comprehensive information on the e-Registry services including step-by-step demonstrations, frequently-asked-questions and information pamphlets are available at the e-Registry and the thematic section on "Electronic Services" on the Registry's website at <u>www.cr.gov.hk</u>.
