Notes for Completion of Form ND7

Introduction

- 1. This form should be used to notify the Registrar of Companies (the Registrar) of any change in particulars of the reserve director of a private company. This form should be delivered to the Registrar for registration within 15 days after the change in the particulars contained in the company's register of directors.
- 2. Please use the appropriate form to report the following changes —

Types of changes	Forms
Nomination or cessation of nomination of the reserve director of a local company	Form ND5
Appointment or cessation of appointment of a director (including an alternate director) or the company secretary of a local company	Form ND2A
Changes in particulars of a director (including an alternate director) or the company secretary of a local company	Form ND2B

- 3. Please fill in all particulars and complete all items consistently in either Chinese or English. Traditional Chinese characters should be used if the form is completed in Chinese. Please note that handwritten forms may be rejected by the Companies Registry.
- **4.** Please complete the Presentor's Reference. Unless the presentor needs to raise a specific issue for the attention of the Companies Registry, no covering letter is required.
- **5.** This form can be delivered by post or in person to "The Companies Registry, 14th floor, Queensway Government Offices, 66 Queensway, Hong Kong". If the form is delivered by post but the Registrar has not received it, the form will not be regarded as having been delivered to the Registrar in satisfaction of the relevant provision of the Companies Ordinance.

Signature

6. This form must be signed by a director or the company secretary. A form which is not properly signed will be rejected by the Companies Registry.

Business Registration Number

7. Please provide the business registration number (i.e. the first 8 digits of the Business Registration Certificate number) issued by the Business Registration Office of the Inland Revenue Department. The numbers after [-] are not required. For companies incorporated on or after 27 December 2023 or re-domiciled companies, the business registration number is also adopted as the "No." on the "Certificate of Incorporation" or "Certificate of Re-domiciliation" issued by the Companies Registry respectively.

Particulars Currently Registered with the Companies Registry (Section 2A)

8. The name of the reserve director must be the same as stated in his or her Hong Kong Identity Card or, if he or she does not hold a Hong Kong identity Card, in his or her passport.

9. (a) For identification purposes, please provide the <u>partial number</u> of Hong Kong Identity Card or, in the absence of a Hong Kong Identity Card, the <u>partial number</u> of passport according to the description of "Partial number" below:

Partial number means —

- (i) if the identification number comprises a sequence of an even number of alphanumeric characters (excluding spaces, punctuation marks and symbols) the first half of the sequence; or
- (ii) if the identification number comprises a sequence of an odd number of alphanumeric characters (excluding spaces, punctuation marks and symbols) the part that begins with the first character in the sequence and ends with the character that falls on the middle of the sequence.

- 11. Please provide the new name of the reserve director. The new name must be the same as stated in his or her Hong Kong Identity Card or, if he or she does not hold a Hong Kong Identity Card, in his or her passport.
- **12.** To report the addition of an alias, please also state all the aliases (including the alias which has been registered with the Companies Registry) of the reserve director in the box provided to facilitate correct updating of the record.
- 13. If the <u>usual residential address</u> of the reserve director has been changed, please specify the effective date of change in the corresponding box and report the new usual residential address of the reserve director separately on a PI-ND7 sheet. PI-ND7 sheet and the information reported therein are withheld from public inspection.

- **14.** Please provide the <u>correspondence address</u> of the reserve director. If a non-Hong Kong address of the reserve director is given, please also complete the box for 'Country/Region'. Post office box numbers are not acceptable.
- **15.** Please provide or update the email address of the reserve director, if any, to facilitate electronic communication. If there are any subsequent changes in the email address, please notify the Companies Registry by completing this form.
- **16.** (a) Please provide the new <u>partial number</u> of Hong Kong Identity Card or, in the absence of a Hong Kong Identity Card, the new <u>partial number</u> and issuing country/region of the passport of the reserve director. Please refer to Note 9 on the details and examples of <u>partial number</u>.
 - (b) Please **DO NOT** fill in the full identification number in the box provided. Information provided in the box is available for public inspection.
 - (c) Please report the full Hong Kong Identity Card number or passport number of the reserve director separately on a PI-ND7 sheet. PI-ND7 sheet and the information reported therein are withheld from public inspection.
 - (d) If the reserve director no longer holds a Hong Kong Identity Card or any passport, please state 'Nil' in the boxes provided. There is no need to submit a PI-ND7 sheet.
