- 申請必須連同費用港幣130元一併交付。如以郵寄方式交付,請以港幣劃線支票繳付費用,抬頭請 註明「公司註冊處」。請勿郵寄現金。
- 5. 本處有權接納或拒絕任何申請。本處發出確認書後,<u>不會退還已繳付的費用</u>。請於交付本申請前登 入本處的電子服務網站或親臨本處的電子服務中心查閱公司的相關資料,以確保申請表格所提供的 資料正確無誤。
- 6. 確認書將會按申請表格內所提供的電郵地址發送至申請人。本處<u>不會</u>以印本形式發出確認書。
- 申請人在本申請表格中向公司註冊處處長(下稱「處長」)所提供的個人資料,處長只會用作處理有 關申請。

- 1. Each application form can be used to apply for a letter of confirmation in respect of one company only.
- 2. A letter of confirmation will be issued to confirm only one item relating to the information of the company as stated in the application form.
- 3. This application form can be delivered via the e-Search Services at the Companies Registry's e-Services Portal (www.e-services.cr.gov.hk). You may also deliver the form by post to "Public Search Section, Companies Registry, 13th floor, Queensway Government Offices, 66 Queensway, Hong Kong" or in person to the e-Services Centre of the Companies Registry ("the Registry") on 13th floor direct.
- 4. This application must be delivered with a fee of HK\$130. For delivery by post, the fee should be paid by cheque which should be crossed and issued in Hong Kong Dollars payable to "Companies Registry". Please do not send cash.
- 5. The Registry may accept or reject any application at its sole and absolute discretion. <u>Fee paid is not refundable</u> after the letter of confirmation has been issued. Applicant is advised to conduct searches on the company online at the Companies Registry's e-Services portal or onsite at the Registry's e-Services Centre before delivery of this application to ensure that the particulars given in the application form are correct.
- 6. The letter of confirmation will be sent to the applicant at the email address provided in the application form. The Registry will **<u>not</u>** issue the letter of confirmation in hard copy form.
- 7. Personal data provided by the Applicant to the Registrar of Companies ("the Registrar") in this application form will be used by the Registrar for processing this application only.
- 8. Provision of the personal data in this application form is voluntary. If the personal data are not provided, the Registry will not be able to process this application.
- 9. Individuals have a right to request access to and correction of his/her personal data held by the Registry pursuant to sections 18 and 22 of the Personal Data (Privacy) Ordinance (Cap. 486). Any such request for access to and correction of such personal data may be made to any officer acting for or on behalf of the Registrar at the Companies Registry, 15th Floor, Queensway Government Offices, 66 Queensway, Hong Kong.
